#### West Kowloon Reclamation Concept Plan Competition

At the Special House Committee meeting held on 24 February 2012, Legislative Council (LegCo) Members requested further information relating to the allegations of conflict of interests involving yourself in the West Kowloon Reclamation Concept Plan Competition (the Competition).

We have taken into account the considerations of confidentiality as well as public interest when addressing the scope of the disclosure to the House Committee, and will disclose our letters dated 14 February 2012, 16 February 2012 and 24 February 2012 to you in relation to proposed disclosure of information concerning the aforementioned allegations of conflict of interests. To enable the public and LegCo to have the full picture, we consider it necessary to disclose also your letters dated 15 February 2012 and 20 February 2012 to us on the same subject and hereby seek your express confirmation that you have no objection to the disclosure of the same.

At the request of LegCo Members, we are prepared to provide the voting record of the other nine jurors on an anonymous basis with a view to showing the voting pattern of the 10-member Jury. Attached herewith are tables showing the votes cast by the 10 jurors (including yourself) in each round of voting (except Round 4, which involved only discussion but not actual voting).
