1. Commencement

These Statutes come into operation on 8 June 2012.

"and, where the context permits, a Department also refers to a School of Studies and Chairman in relation to a Department also refers to Director of a School".

"**Provost** (常務副校長) means the Provost of the University appointed by the Council;".

Explanatory Note

These Statutes amend the Statutes of The Chinese University of Hong Kong in Schedule 1 to The Chinese University of Hong Kong Ordinance (Cap. 1109) to provide for—

- (a) the inclusion of School of Studies to have the same status as Departments;
- (b) the inclusion of the Provost;
- (c) the removal of the power and duty of the Senate to make recommendation to the Council relating to all teaching posts and assignment of teachers;
- (d) the revised composition of the Board of Faculty; and
- (e) the revised composition of the Board of Department.
