Action

I Election of Chairman

Mr Abraham SHEK, the member who had the highest precedence in the Council among members of the Bills Committee present at the meeting, presided over the election of Chairman of the Bills Committee. He invited nominations for the chairmanship.

- 2. Mr NG Leung-sing was nominated by Mr CHAN Kin-por and the nomination was seconded by Ms Starry LEE. Mr NG Leung-sing accepted the nomination.
- 3. <u>Mr Abraham SHEK</u> asked if there were other nominations. Mr Kenneth LEUNG was nominated by <u>Mr Dennis KWOK</u> and the nomination was seconded by <u>Ms Cyd HO</u>. <u>Mr Kenneth LEUNG</u> accepted the nomination. There was no other nomination.
- 4. Mr Abraham SHEK announced that voting be conducted by secret ballot. After members present had cast their votes, Mr Abraham SHEK invited Mr CHAN Kin-po and Mr Dennis KWOK, who had nominated the two candidates, to monitor the counting of votes. Of the members present, six voted for Mr NG Leung-sing and three voted for Mr Kenneth LEUNG. Mr Abraham SHEK declared that Mr NG Leung-sing was elected the Chairman of the Bills Committee. Mr NG Leung-sing then took the chair.

Election of Deputy Chairman

5. <u>The Chairman</u> called for nominations for the deputy chairmanship of the Bills Committee. Mr Kenneth LEUNG was nominated by <u>Mr Abraham SHEK</u> and the nomination was seconded by <u>Mr Dennis KWOK</u>. <u>Mr Kenneth LEUNG</u> accepted the nomination. There being no other nominations, Mr Kenneth LEUNG was declared the Deputy Chairman of the Bills Committee.
