The legal adviser to the Bills Committee was requested to review the Chinese version of the draft CSAs.

Given the large number of public officers of the Customs and Excise Department involved in carrying out the provisions of the Ordinance, they were specifically referred to in the proposed sections 7(3) and 8(8), rather than covered under "authorized officer", so as to obviate the need to appoint each of them as "authorized officer" under section 14 of the Ordinance.
