ELECTION OF PRESIDENT

CLERK (in Cantonese): Council will now proceed to elect the President of the Legislative Council.

The procedure for the election of the President of the Legislative Council is set out in the Schedule to the Rules of Procedure. In accordance with Rule 1A of the Rules of Procedure, I now invite Mr Albert HO to preside at the election.

MR ALBERT HO (in Cantonese): Honourable colleagues, the Legislative Council Secretariat issued a notice on 5 October 2012 informing Members that two valid nominations for the office of President had been received by the close of the nomination period at 12 midnight on 4 October 2012.

The Members being nominated, in the order of receipt of the nominations by the Secretariat, are Mr Alan LEONG and Mr Jasper TSANG. Mr Alan LEONG is nominated by Mr LEE Cheuk-yan and seconded by Dr Fernando CHEUNG, Mr IP Kin-yuen, Mr Charles MOK, Mr Frederick FUNG, Dr Kenneth CHAN, Mr Kenneth LEUNG, Ms Claudia MO, Mr Ronny TONG, Ms Emily LAU and Ms Cyd HO. Mr Jasper TSANG is nominated by Mr TAM Yiu-chung and seconded by Mr WONG Kwok-kin, Mr James TIEN, Mr Jeffrey LAM, Mr CHAN Kin-por and Mr MA Fung-kwok.

In accordance with the procedure for the election of the President of the Legislative Council, a vote by secret ballot shall now be conducted. Each Member present, including myself, will receive a ballot paper and a chop with a "\scrtw". The names of the two candidates have been printed on the ballot paper. Members taking part in voting shall mark a "\scrtw" in the box opposite the name of the candidates — only one candidate — on the ballot paper using the chop received.

Each ballot paper to be collected later shall be marked with only one "\sqrt"; any ballot paper marked with more than one "\sqrt" or not marked shall be discarded. So, the procedure of today is very simple, and Members only take part in voting. Are there any questions?

(Mr LEUNG Kwok-hung stood up)

Mr LEUNG Kwok-hung, you may speak in your seat.

MR LEUNG KWOK-HUNG (in Cantonese): I have a question. It is said that Mr Jasper TSANG is a member of the Chinese Kuomintang and I would like to ask him this question as today is the Double Ten Day. I once asked him if he was a member of the Chinese Communist Party but he told me that it was inappropriate for him to respond. I have just come back from Taiwan. I received a secret report yesterday, stating that Mr Jasper TSANG, a secret member of the Kuomintang, might take up the reins of the Legislative Council is he present in this Chamber I once asked him if he was a member of the Communist Party

MR ALBERT HO (in Cantonese): Mr LEUNG, I have heard your question. I am really sorry, a two-hour special forum was held the day before yesterday, and Members had in fact, someone raised a similar question on that day but

MR LEUNG KWOK-HUNG (in Cantonese): I am talking about being a member of the Kuomintang

MR ALBERT HO (in Cantonese): we do not have a question and answer session today and Members can only take part in voting

MR LEUNG KWOK-HUNG (in Cantonese): Is that so? Mr Jasper TSANG, please state whether you are a member of the Kuomintang

MR ALBERT HO (in Cantonese): Mr Albert CHAN.

MR ALBERT CHAN (in Cantonese): President, can the Legal Adviser or the Secretary General answer my question? It is very important for the President of the Legislative Council to be impartial. If he does not disclose his special status, the impartiality of the President of the Legislative Council will be affected when he has to perform certain tasks in secret. My question is: on such an important issue in fact, over the many years in the past, I have kept asking on different occasions whether certain candidates were members of certain political parties, because being a member of a certain political party would affect the impartiality of the candidate if he took up the post of the President. Will the Secretary General or the Legal Adviser give a clear answer? If he is a member and he does not respond

MR ALBERT HO (in Cantonese): Mr CHAN, your question is very clear. In chairing the meeting today, I can only tell you that, in accordance with the Rules of Procedure, nobody can answer your question today. You can certainly follow up; we can all follow up this issue in accordance with law. If you want to make a challenge, you may do so in various ways. Yet, under the order of business today, it is impossible for a question and answer session to be arranged, and I believe neither the Secretary General nor the Legal Adviser can answer your question today.

Mr WONG Yuk-man.

MR ALBERT CHAN (in Cantonese): President, I would like to follow up this issue again. If the person concerned neither admits nor denies his status, will

this uncertainty cast doubts on the authority or impartiality of the President of the Legislative Council? Why am I so concerned about this issue? It is because when the President ended the filibuster at the last session, rumour had it that the Liaison Office of the Central People's Government in the Hong Kong Special Administrative Region ordered to end the filibuster, and this is why the filibuster was halted abruptly

MR ALBERT HO (in Cantonese): I have heard your question but

MR ALBERT CHAN (in Cantonese): this readily confirms the importance that "being a member of the Communist Party will affect the impartiality of the President".

MR ALBERT HO (in Cantonese): Mr CHAN, I know that all of us are concerned about these issues. Nevertheless, as you may also understand, in accordance with the Rules of Procedure, the agenda of today is only to elect the President. If you think the President elected has shortcomings or he is not qualified to serve as President, you can certainly exercise your legal rights and make a challenge in accordance with law.

Mr WONG Yuk-man.

MR WONG YUK-MAN (in Cantonese): This is to give Mr Jasper TSANG an opportunity, but he simply repeated the same reply given four years ago. He should either say "No" — telling lies like LEUNG Chun-ying — or say "Yes", he should not resort to sophistry by playing language "hypocrisy" — a deceitful tactic. We may have a less favourable impression of him. He has done a pretty good job over the past four years, except the worst ever decision to cut the filibuster. Why did he refuse to admit?

MR ALBERT HO (in Cantonese): That is enough, Mr WONG.

MR WONG YUK-MAN (in Cantonese): I raise the question today to let the public hear.

MR ALBERT HO (in Cantonese): Mr WONG, the question raised by you the day before yesterday was loud and clear. Everyone had heard it, and he had also given a reply in his own way. I am sorry that we really cannot spare any more time for Members to raise questions today.

If there are no questions, we now proceed to vote.

MR LEUNG KWOK-HUNG (in Cantonese): Can a legal person run for the President?

MR ALBERT HO (in Cantonese): Today, all votes are personal votes and each Member can only have one vote.

MR LEUNG KWOK-HUNG (in Cantonese): I have no idea if he is a human being. If someone asks him if he is a human being, his reply is "maybe", "maybe not", "inappropriate to talk about"

MR ALBERT HO (in Cantonese): Your opinion has been clearly heard.

MR LEUNG KWOK-HUNG (in Cantonese): Is there any difference between him and a legal person?

MR ALBERT HO (in Cantonese): Fine. May I ask the Secretariat staff to distribute the ballot papers?

(Each Member present received one ballot paper and one chop)

MR ALBERT HO (in Cantonese): Members should be ready to vote, right?

If there is no question, the Secretariat staff will now collect the ballot papers. Members need not fold the ballot papers, just put them into the ballot box. The Secretariat staff will collect the ballot papers row by row.

(After the collection of ballot papers and chops)

MR ALBERT HO (in Cantonese): Have all Members cast their votes? Has anyone not cast his vote? No?

Good. The ballot papers shall now be counted by way of reading out aloud the votes. Will the two Members making the nominations, Mr LEE Cheuk-yan and Mr TAM Yiu-chung, please come forward to the table to supervise the counting of ballot papers.

Staff members of the Secretariat will assist in reading out the votes. Let us first count the number of ballot papers.

(Mr LEE Cheuk-yan and Mr TAM Yiu-chung stood before the table to supervise the counting of ballot papers while staff members of the Secretariat read out and counted the votes)

MR ALBERT HO (in Cantonese): Will the two Members please return to their seats.

(The Clerk reported the result to Mr Albert HO, who then checked and confirmed the result)

MR ALBERT HO (in Cantonese): Honourable Members, I now announce the voting result: Mr Alan LEONG has received 27 votes, and Mr Jasper TSANG, 43 votes. I now declare Mr Jasper TSANG elected as the President of the current-term Legislative Council. Congratulations, Mr TSANG.

Will the President please take the chair?

(Mr Albert HO returned to his seat)

PRESIDENT (in Cantonese): I thank Members for supporting me to take up the post of the President of the current-term Legislative Council. Also, I have to thank them for voicing their views and requests to me, as well as levelling criticisms at my work as President of the last-term Legislative Council on different occasions and through various channels, especially at the forum held the day before yesterday. I will stay cautious and apprehensive, perform my duties faithfully and work together with Members to do our best to enable this Council to effectively perform its constitutional duty, so as to live up to the expectations of the public.
