# First Reading and Second Reading

After the above Bills were read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure, the public officers moved the Second Reading of the Bills respectively. The President proposed the questions on the Second Reading of the respective Bills and referred them to the House Committee in accordance with Rule 54(4) of the Rules of Procedure. The debates on the Bills were adjourned.

## Resumption of Second Reading debate and Committee stage

- Appropriation Bill 2013 : Financial Secretary

The Second Reading debate on the above Bill, which was moved on 27 February 2013, resumed. After Members and public officers had respectively spoken, question on the Second Reading of the Bill was put and agreed to (details of division in **Appendix 1**). The Bill was read the second time and committed to a committee of the whole Council.

(During the Committee stage of the Bill, the meeting was suspended at 10:00 pm on 24 April 2013, 9:52 pm on 25 April 2013, 12:58 pm on 26 April 2013, 9:48 pm on 29 April 2013 and 12:59 pm on 30 April 2013, and resumed at 9:00 am on 25, 26, 29 and 30 April 2013 and 2 May 2013.)

The Council went into committee and considered the Bill. In accordance with Rule 68 of the Rules of Procedure, the committee first considered the Schedule to the Bill. The Chairman proposed the question that the sums for the 26 heads, as set out in the Official Record of Proceedings, to which no amendments were proposed stand part of the Schedule. After Members had spoken, the question was put and agreed to (details of division in **Appendix 2**).

The committee proceeded to consider a total of 710 amendments proposed by five Members to the Bill as set out on the Agenda. The Chairman directed that 113 joint debates and 35 individual debates on amendments be held, and the amendments be voted upon one by one after all the debates had been held.

Members respectively spoke in the first four debates covering a total of 134 amendments to Head 21. During the fifth debate on five amendments to Head 22, Hon Albert CHAN drew the attention of the Chairman to the absence of a quorum. The Chairman then directed the Clerk to summon Members to the meeting.

#### Next meeting

A quorum was not present 15 minutes after Members had been summoned. The Council resumed. The President adjourned the Council in accordance with Rule 17(3) of the Rules of Procedure.

The Council was adjourned at 9:16 am on 2 May 2013.
