The Bill was read the third time and passed.

# District Councils (Amendment) Bill 2013 : Secretary for Constitutional and Mainland Affairs

The debate on the Second Reading of the above Bill, which was moved on 20 February 2013, resumed. After Members and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to (details of division in **Appendix 1**). 
