Question under Rule 24(4) of the Rules of Procedure

Bills

First Reading and Second Reading

After the Supplementary Appropriation (2012-2013) Bill was read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure, the Secretary for Financial Services and the Treasury moved the Second Reading of the Bill. The President proposed the question on the Second Reading of the Bill and referred it to the House Committee in accordance with Rule 54(4) of the Rules of Procedure. The debate on the Bill was adjourned.

Resumption of Second Reading debate, Committee stage and Third Reading

The debate on the Second Reading of the Education (Amendment) Bill 2013, which was moved on 27 March 2013, resumed. After Members and the public officer had respectively spoken, the President's Deputy put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1 to 5 stand part of the Bill was proposed, put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage without amendment. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.
