Addresses

The Members presenting the papers as set out on the Agenda respectively addressed the Council.

Questions

Six oral questions as set out on the Agenda (i.e. Questions 1 to 6) were put by Members and oral replies were given by the public officers.

Written replies to Questions 7 to 22 as set out on the Agenda were tabled.

Bills

First Reading and Second Reading

After the Securities and Futures (Amendment) Bill 2013 was read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure, the Secretary for Financial Services and the Treasury moved the Second Reading of the Bill. The President's Deputy proposed the question on the Second Reading of the Bill and referred it to the House Committee in accordance with Rule 54(4) of the Rules of Procedure. The debate on the Bill was adjourned.

Resumption of Second Reading debates, Committee stage and Third Reading

— Arbitration (Amendment) Bill 2013 : The Secretary for Justice

The debate on the Second Reading of the above Bill, which was moved on 24 April 2013, resumed. After Members and the public officer had respectively spoken, the President's Deputy put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 2, 3, 6 to 19, 21 and 22 stand part of the Bill was proposed, put and agreed to.

The question that 1, 4, 5 and 20 stand part of the Bill was proposed. The public officer moved amendments to clauses 1, 4, 5 and 20 and spoke on the amendments. The question on the amendments was put and agreed to. The question that clauses 1, 4, 5 and 20 as amended stand part of the Bill was proposed, put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.

— Hong Kong Arts Development Council : Secretary for Home Affairs (Amendment) Bill 2013

The debate on the Second Reading of the above Bill, which was moved on 8 May 2013, resumed. After Members and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clause 1 stand part of the Bill was proposed, put and agreed to.

The question that clauses 2 and 3 stand part of the Bill was proposed. New clause 4 was read the first time. Hon Cyd HO moved the Second Reading of new clause 4. The Chairman proposed the question on the Second Reading of new clause 4, and ordered a joint debate on the original provisions of clauses 2 and 3 and the amendments thereto, and the proposed new clause 4. After Members and the public officer had respectively spoken, the Chairman put the question on the Second Reading of new clause 4. The question was negatived (details of division in **Appendix 1**). As the motion for the Second Reading of new clause 4 was negatived, Hon Cyd HO could not move her amendments to clauses 2 and 3.

Motion moved without notice by Hon Andrew LEUNG to shorten the duration of the division bell for further divisions in relation to the provisions of the Bill and amendments thereto was proposed, put and agreed to.

The question that clauses 2 and 3 stand part of the Bill was put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage without amendment. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.

— Inland Revenue (Amendment) Bill 2013 : Secretary for Financial Services and the Treasury

The debate on the Second Reading of the above Bill, which was moved on 24 April 2013, resumed. After Members and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1 to 9 stand part of the Bill was proposed, put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage without amendment. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.

- Inland Revenue and Stamp Duty : Secretary for Financial Services and Legislation (Alternative Bond Schemes) the Treasury (Amendment) Bill 2012

The debate on the Second Reading of above Bill, which was moved on 9 January 2013, resumed. After Members and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1, 2, 3, 5, 7 to 16, 22 to 29 and 31 to 35 stand part of the Bill was proposed, put and agreed to.

The question that clauses 4, 6, 17 to 21 and 30 stand part of the Bill was proposed. The public officer moved amendments to clauses 4, 6, 17 to 21 and 30 and spoke on the amendments. The question on the amendments was put and agreed to. The question that clauses 4, 6, 17 to 21 and 30 as amended stand part of the Bill was proposed, put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.

- Supplementary Appropriation : Secretary for Financial Services and (2012-2013) Bill the Treasury

The debate on the Second Reading of the above Bill, which was moved on 19 June 2013, resumed. The President put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The questions that clauses 1 and 2 and the Schedule stand part of the Bill were respectively proposed, put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage without amendment. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.

— Air Pollution Control (Amendment) Bill : Secretary for the Environment
2013

The debate on the Second Reading of the above Bill, which was moved on 20 March 2013, resumed. After Members and the public officer had respectively spoken, the President's Deputy put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1 to 4, 6, 7 and 8 stand part of the Bill was proposed, put and agreed to.

The question that clause 5 stand part of the Bill was proposed. Hon Dennis KWOK moved an amendment to clause 5. The Chairman's Deputy ordered a joint debate on the original provision of clause 5 and the amendment thereto. After Members and the public officer had respectively spoken, the Chairman put the question on the amendment. The question was negatived (details of division in **Appendix 2**).

The question that clause 5 stand part of the Bill was put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage without amendment. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to (details of division in **Appendix 3**). The Bill was read the third time and passed.
