Council meeting of 3 July 2013

Amendments to motion on "Facing up to the aspirations of the people participating in the march on 1 July"

Further to LC Paper No. CB(3) 700/12-13 issued on 19 June 2013, Hon Claudia MO and Hon Christopher CHEUNG have respectively given notices of their intention to move separate amendments to Hon SIN Chung-kai's motion on "Facing up to the aspirations of the people participating in the march on 1 July" scheduled for the Council meeting of 3 July 2013. As directed by the President, Hon Claudia MO's and Hon Christopher CHEUNG's amendments will be printed in the terms in which they were handed in on the Agenda of the Council.

- 2. The President will order a joint debate on the above motion and the two amendments. To assist Members in debating the motion and amendments, I set out below the procedure to be followed during the debate:
 - (a) the President calls upon Hon SIN Chung-kai to speak and move his motion;
 - (b) the President proposes the question on Hon SIN Chung-kai's motion;
 - (c) the President calls upon the two Members who wish to move amendments to speak in the following order, but no amendment is to be moved at this stage:
 - (i) Hon Claudia MO; and
 - (ii) Hon Christopher CHEUNG;

- (d) the President calls upon the public officer(s) to speak;
- (e) the President invites other Members to speak;
- (f) the President gives leave to Hon SIN Chung-kai to speak for the second time on the two amendments;
- (g) the President calls upon the public officer(s) to speak again;
- (h) in accordance with Rule 34(5) of the Rules of Procedure, the President has decided that he will call upon the two Members to move their respective amendments in the order set out in paragraph (c) above. The President invites Hon Claudia MO to move her amendment to the motion, and forthwith proposes and puts to vote the question on the amendment;
- (i) after Hon Claudia MO's amendment has been voted upon, the President deals with Hon Christopher CHEUNG's amendment to the motion; and
- (j) after Hon Christopher CHEUNG's amendment has been dealt with, the President calls upon Hon SIN Chung-kai to reply. Thereafter, the President puts to vote the question on Hon SIN Chung-kai's motion, or his motion as amended, as the case may be.
- 3. For Members' reference, the terms of the original motion and of the motion, if amended, are set out in the **Appendix**.

Motion debate on "Facing up to the aspirations of the people participating in the march on 1 July" to be held at the Council meeting of 3 July 2013

1. Hon SIN Chung-kai's original motion

That this Council urges the Administration to face up to the dissatisfaction with LEUNG Chun-ying's Government expressed by the people participating in the march on 1 July this year and their relevant aspirations.

2. Motion as amended by Hon Claudia MO

That, as the Chief Executive LEUNG Chun-ying has not listened to public opinions, this Council urges the Administration to face up to the dissatisfaction with LEUNG Chun-ying's Government expressed by the people participating in the march on 1 July this year and their relevant aspirations, and at the same time adopt appropriate measures to allay public resentment, including immediately launching consultation on constitutional reform and safeguarding freedom of the press.

3. Motion as amended by Hon Christopher CHEUNG

That this Council urges the Administration to face up to the dissatisfaction with LEUNG Chun-ying's Government expressed by, in addition to facing up to the assessments by and aspirations of the people participating in the march on 1 July this year and their relevant aspirations in regard to the performance of LEUNG Chun-ying's Government on policy administration in the past year, attach importance to the expectations of the silent majority of the public for maintaining Hong Kong's prosperity, stability and development, including adopting effective measures to drive Hong Kong's sustainable economic development, enhance its competitiveness and improve people's livelihood, so as to alleviate the pressure of life of the grassroots and the middle class; and facilitating various sectors in society to forge a consensus on achieving the

ultimate goal of universal suffrage through rational and peaceful channels during the consultation on constitutional reform to be launched later.
