#### Add

"9. Eligibility Criteria for Individual Arts Workers to Participate in the Nomination of Representatives of Arts Interests for the Council

The individual must be aged 18 or above and—

- (a) be a current or former member, co-opted member, arts adviser or examiner of the Council, since its establishment on 15 April 1994;
- (b) be a current or former arts adviser of the Leisure and Cultural Services Department (*LCSD*) since 1 January 2000;
- (c) have been a winner or an announced finalist of the arts achievement award of the Council since its establishment on 15 April 1994;

- (d) have been a winner or an announced finalist of a recognized local arts competition or award;
- (e) have been successful in obtaining grant, financial sponsorship or venue sponsorship from Council, LCSD, the Home Affairs West Bureau. the Kowloon Cultural District Authority, the Hong Kong Academy Performing Arts or the Hong Kong Arts Centre for an arts project submitted in his or her name:
- (f) have obtained fees from the Council, LCSD, the Home Affairs Bureau. the West Kowloon Cultural District Authority, the Hong Kong Academy Performing Arts or the Hong Kong Arts Centre for direct engagement in arts creation, direction, performance, exhibition, production or technical support or arts administration of an arts project;
- (g) be or have been in collaboration with LCSD in holding an arts exhibition or competition, or have participated in such an exhibition or competition in his or her name since 1 January 2000;
- (h) be a full-time or part-time teacher or instructor or tutor of a subject relating to arts administration, arts criticism, arts education, Chinese opera (Xiqu), dance, drama, film arts, literary arts, music or visual arts employed by a local tertiary institution or its school of continuing studies, secondary school or primary school in Hong Kong;
- (i) a graduate of be an arts programme in Arts Administration, Arts Criticism, Arts Education, Chinese Opera (Xiqu), Dance, Drama, Film Arts, Literary Arts, Music or Visual Arts at bachelor's degree level or above run by a local university or tertiary institution;

- (j) be an individual artist tenant of the Jockey Club Creative Arts Centre, the Cattle Depot Artist Village or the Hong Kong Arts Centre;
- (k) be a member of an arts organization registered as member of an organization which is specified in the Gazette under section 3(5) of this Ordinance and has joined the arts organization for not less than 1 year; or
- (l) be an employee of an arts organization registered as member of an organization which is specified in the Gazette under section 3(5) of this Ordinance and—
  - (i) has been directly involved in arts creation, direction or performance in the arts organization for not less than 1 year; or
  - (ii) be a full-time employee in the arts organization and has been responsible coordination or promotion of arts events or stage management (not including general administration, finance, human resources and other technical support duties) in the organization for not less than 1 year.".".
