The meeting continued the deliberation on item FCR(2012-13)54 relating to the funding and establishment proposals on the Old Age Living Allowance (OALA).

- 2. <u>The Chairman</u> took turns to put to vote the questions that motions numbered 34 to 108 be proceeded forthwith. As requested by members, the division bell was rung for one minute before members voted on individual questions. All questions were voted down by a majority of members.
