The Bureau has replied that "the EOC has no plan to allocate funding to conduct publicity activities and studies on promoting non-discrimination on the ground of sexual orientation because the issue is not directly within the EOC's ambit." However, according to Dr. York CHOW who has assumed the position of Chairperson of EOC, preventing discrimination against those of different sexual orientation is his priority task during his tenure with the EOC. Why is there such a great discrepancy (between the remarks made by the Bureau and the Chairperson)? Who has gone wrong, the Secretary for Constitutional and Mainland Affairs or Dr. CHOW?

#### Reply:

The Equal Opportunities Commission (EOC) is an independent statutory body established to perform the functions vested upon it by the 4 existing anti-discrimination Ordinances (i.e. the Sex Discrimination Ordinance, Disability Discrimination Ordinance, Family Status Discrimination Ordinance and Race Discrimination Ordinance). At present, the EOC's functions include, inter alia, the elimination of discrimination in the specific areas covered by the 4 Ordinances on the grounds of sex, race, family status and disability. The public education and publicity activities on elimination of discrimination on the ground of sexual orientation and gender identity are implemented by the Gender Identity and Sexual Orientation Unit of the Constitutional and Mainland Affairs Bureau.

2. To our understanding, the EOC may wish to discuss the question of discrimination on the ground of sexual orientation and gender identity, including whether and, if so, how to conduct studies and to follow up with the Administration on the need to enact legislation on this subject. The Administration will continue to liaise with EOC in this regard.

Reply:

The Office of the Privacy Commissioner for Personal Data received a total of 2 849 enquiries (from 1 October 2012 to 10 April 2013) related to the new provisions introduced under the Personal Data (Privacy) (Amendment) Ordinance 2012. The key issues covered include: (1) rights and obligations under the new requirements on the use of personal data in direct marketing; (2) grandfathering arrangements under the amended Personal Data (Privacy) Ordinance; and (3) making opt-out requests from direct marketing activities.

2. A total of 70 complaints (from 1 October 2012 to 10 April 2013) related to the new provisions were received. 65 out of the 70 complaints are related to direct marketing notifications. The key issues covered therein include: (1) dissatisfaction with data users' intention to transfer complainant's personal data to third parties; (2) dissatisfaction with data users' recent sending of direct marketing notifications; and (3) problems associated with the use of the response channel provided by data users. 5 out of the 70 complaints concern the data users' continued use of complainants' personal data for direct marketing despite the latter's opt-out request.

Reply:

Human rights education in schools and the work of the Committee on the Promotion of Civic Education (CPCE) fall under the purview of the Education Bureau and Home Affairs Bureau respectively.

2. Human rights education is incorporated in different Key Learning Areas/subjects of the school curriculum in primary and secondary schools, such as General Studies at primary level, Life and Society at junior secondary level, and Liberal Studies at senior secondary level. There are relevant topics in the curricula of these Key Learning Areas/subjects to enhance students' understanding towards concepts related to human rights education. Expenditures for the related curriculum development work, which includes promotion in schools, the provision of professional development programmes for school heads and teachers, production of learning and teaching resources, provision of learning activities for students and collaboration with other government departments and bodies, are absorbed by the recurrent expenditures of relevant sections of the Education Bureau. These are integral parts of the curriculum; hence, we are unable to provide a separate breakdown on the expenditure incurred in this aspect.

3. The CPCE promotes civic education outside schools through various channels such as sponsoring community organisations to organise activities, publications, promotional programmes, production of TV programmes, thematic workshops and exhibitions. The activities may promote multiple core values at the same time. As all these promotional activities constitute an integral part of CPCE's expenditure, a separate breakdown of expenditure on activities promoting a specific value or civic concept is not available.

Reply:

The Hong Kong Economic and Trade Office in Shanghai (the Shanghai ETO) has been assisting Hong Kong residents in its coverage area (viz. Shanghai Municipality and the provinces of Jiangsu, Zhejiang, Anhui and Hubei) through the provision of information and assistance and the organisation of activities such as seminars and gatherings.

2. Since cases of human infection of Influenza A (H7N9) in the eastern region of the Mainland were reported in March 2013, the Shanghai ETO has been closely monitoring the development through various sources, such as close liaison with relevant government authorities and local media and tracking of relevant government and media websites. To keep the Hong Kong residents and groups in its coverage area abreast of latest developments, the Shanghai ETO has been issuing notices to all Hong Kong chambers of commerce and other Hong Kong stakeholder groups in the area. These notices set out information on the latest developments about cases of human infection, the precautionary measures to take, and means to obtain further information and assistance. In addition, the Shanghai ETO proactively sought to establish contact with visiting student groups from Hong Kong that came to its notice so that the latter might contact the ETO if they required any assistance.

3. The Shanghai ETO will continue to keep contact with various Hong Kong resident groups in the area to ensure timely and effective dissemination of information and provision of assistance as and when necessary.

The total expenditure to be involved for creation of 10 new posts will be about \$3.9 million, to be offset by the reduction in expenditure of about \$0.3 million due to the deletion of one post within 2013-14. Therefore, the expenditure involved for the net increase of nine posts in 2013-14 is about \$3.6 million.

- 2. The additional expenditure involved for the new posts is set out below
  - (a) \$2.6 million for six time-limited posts, including one Administrative Officer, one Senior Executive Officer, one Executive Officer II and three Assistant Clerical Officer, to be created when public consultation on the two electoral methods for 2016 and 2017 is launched;
  - (b) \$0.6 million for one Executive Officer I post for supporting work on promotion of the Basic Law;
  - (c) \$0.3 million for one Supplies Supervisor I post for strengthening administrative support for the Constitutional and Mainland Affairs Bureau;
  - (d) \$0.2 million for one Assistant Clerical Officer post for strengthening housekeeping work of the Mainland and Taiwan Offices; and
  - (e) \$0.2 million for one time-limited Assistant Clerical Officer post for strengthening clerical support for "homeland relationship".

The above creation of 10 new posts will be offset by the deletion of one time-limited Executive Officer II post in 2013-14.
