## Reply:

The approved commitment for the one-off assistance package to fishermen affected by the trawl ban is mainly for making ex-gratia payments to affected trawler owners. The processing of applications has largely been completed. We have disbursed the bulk of the ex-gratia payments to eligible applicants in 2012-13. Therefore, the projected cash flow for the one-off assistance package will be reduced in 2013-14.

According to the Planning Department, there are about 3 278 hectares of land zoned as "Agriculture" on Outline Zoning Plans and Development Permission Area Plans gazetted under the Town Planning Ordinance, Cap. 131. As the land in most cases is under private ownership, how far we could take forward the agricultural land rehabilitation programme depends on the willingness of the landowners to lease out their land for farming. Moreover, the rents will be subject to negotiation between the landowners and the farmers. Upon successful leasing of land by the farmers, the Agriculture, Fisheries and Conservation Department will offer them a variety of services including technical support in respect of advice on crop husbandry and pest control, soil and water analysis, as well as assistance such as the lending of farm machinery, and the provision of low interest loans where necessary.

- (1) It refers to those animal welfare organisations (AWOs) that are recognised by the Agriculture, Fisheries and Conservation Department (AFCD) as being suitable partners for providing animal re-homing services. These AWOs must operate on a non-profit making basis and comply with the requirements imposed by AFCD in ensuring proper re-homing of animals. There are currently 13 such AWOs.
- (2) At present, only those AWOs mentioned in (1) above are eligible to apply for subvention. To strengthen collaboration with and the provision of support to other AWOs, AFCD is planning to extend the partnership programme to cover other AWOs not currently engaged in animal re-homing, thereby facilitating them to carry out programmes and activities relating to promotion of animal welfare and proper animal management. This will allow more AWOs to enter into partnership with AFCD and thus become eligible to apply for subvention. To ensure proper use of public money, only those AWOs that are properly constituted with good record keeping and accounting systems and managed by people with a strong sense of responsibility will be considered.
- (3) Over the past two years, a total of nine applications for subvention have been received from the partnering AWOs including the Hong Kong Society of Herpetology Foundation, Hong Kong Dog Rescue, Lifelong Animal Protection Charity, Society for Abandoned Animals and Hong Kong Rabbit Society. All applications have been either fully or partly approved taking into account their relevance to the objective of the subvention (i.e. to support activities for the promotion of animal welfare and proper animal management), the justifications for the funding applied, the cost-effectiveness of the proposed projects/activities, and the availability of fund, etc.

Pursuant to reply no. FHB(FE)098, the Administration is requested to provide information on whether and what measures would be implemented (such as <u>development</u> of rapid food tests) to improve the safety control and monitoring of imported food from the Mainland.

### Reply:

The Government is committed to enhancing food safety through a multi-pronged approach. It adopts the "from farm to table" strategy to safeguard public health by ensuring that food consumed by the public meets safety standards.

All live food animals and freshwater fish, and chilled or frozen meat or poultry imported from the Mainland must come from registered farms and processing plants recognised by the State General Administration of Quality Supervision, Inspection and Quarantine, and be accompanied with official health certificates issued by the Mainland authorities. Other than carrying out inspections of these farms and processing plants, the Centre for Food Safety (CFS) inspects live food animals, meat and poultry upon arrival at the boundary control points, and verifies the import documents including health certificates. CFS takes samples from each consignment of live poultry for avian influenza testing. Other imported livestock including pigs, cattle and goats have to pass drug residues testing, ante-mortem and post-mortem inspections at the slaughterhouses before they are supplied to local retail outlets.

All vegetables supplied to Hong Kong must also come from registered vegetable farms and production and processing establishments under the supervision of the relevant Entry-Exit Inspection and Quarantine Bureau. Other than conducting inspection of vegetable farms, CFS checks the documents accompanying the vegetable consignments, inspects the vegetables and takes samples for tests at the boundary control point.

In addition, CFS takes food samples at the import, wholesale and retail levels under its Food Surveillance Programme, to ensure that food on sale complies with the relevant legislation and is fit for human consumption. About 65 000 samples were tested in 2012. The overall satisfaction rate was 99.8%.

- (b) The details on practical training in social media attended by officers in the Food and Health Bureau and departments/pubic bodies under its purview are at Annex 2.

- (c) The Office of the Government Chief Information Officer (OGCIO) has set up a thematic website on social media in the government's intranet to provide departments/bureaux with guidelines, tips and tools on the use of social media.
- (d) While public opinions on specific issues are being collected through the setting up of dedicated websites, mailboxes and hotlines, we will continue to explore the possibility of collecting public opinions through different means and channels including those on the internet.
