Reply:

Financial Services and the Treasury Bureau and the Official Receiver's Office ("ORO") plan to launch a public consultation exercise on legislative proposals to improve the corporate insolvency law in the second quarter of this year. In parallel, we are also studying various relevant key issues in respect of the proposed corporate rescue procedure and working further on the detailed legislative proposals, having regard to the public consultation in late 2009.

Legal research on the relevant law and procedures and comparable studies of other jurisdictions such as the UK and Australia are conducted in-house by legal officers in ORO. Reference has also been made, where appropriate, to the relevant studies and recommendations of the Law Reform Commission as contained in its "Report on the Winding-up Provisions of the Companies Ordinance" and "Report on Corporate Rescue and Insolvent Trading". ORO has no plan at present to engage consultants to assist its work in this regard.

In the May 2013 issue of the "Hong Kong Monthly Digest of Statistics", the Census and Statistics Department ("C&SD") will release statistics on cultural and creative industries ("CCI"), the coverage of which fully comply with the international statistical guidelines promulgated in the "Creative Economy Report 2010" of the United Nations Conference on Trade and Development ("UNCTAD"). In order to better reflect the economic situation in Hong Kong, the more refined classification of CCI in Hong Kong comprises 11 component domains as against 9 domains recommended by UNCTAD. Apart from industry statistics (value added and employment), C&SD will at the same time release additional statistics on trade in cultural and creative goods and services, compiled based on UNCTAD international classification with adaptations to the economic structure of Hong Kong.

In accordance with the Clearing and Settlement Systems Ordinance, except for specified circumstances (e.g. certain legal proceedings), the Monetary Authority shall not disclose information about the bonds held by individual institutions in operating the Central Moneymarkets Unit without the consent of the relevant institutions.

This notwithstanding, according to the Hong Kong Monetary Authority's understanding from the Primary Dealers, the broad distribution of investors of institutional government bonds at tenders is as follows –

In respect of Reply Serial No. FSTB(FS)141, will the Administration advise us that, after the elapse of 9 years, the reason for not yet fully implemented the recommendations of the Information Systems Strategy Study, which was completed in 2004. Please explain the slow progress.

Reply:

The Information Systems Strategy Study ("ISSS") conducted in 2004 recommended a total of 16 strategic information technology ("IT") projects, among which 9 projects were identified as priority items. The remaining 7 projects will be implemented later so as to take into account the recommendations of the interim review after the completion of the 9 projects in the light of the latest technological developments.

The Census and Statistics Department ("C&SD") has implemented the 9 strategic IT projects mentioned above progressively. So far, 7 projects have been fully completed. The remaining 2 projects are a Computer-assisted Telephone Interview ("CATI") System and a Data Collection System using Imaging Technology ("Imaging"). There has been some delay in the progress of these 2 projects owing to the following reasons:

- (i) CATI System: The tender for the project turned out to be unsuccessful in 2011 as no suitable company was identified. A re-tendering process is now underway and C&SD has updated the tender specifications to incorporate the latest system requirements and trends in technological developments.
- (ii) Imaging System: Latest trend has shown that paper form questionnaire is being replaced by electronic questionnaire, thus rendering the application of imaging technology in processing survey questionnaires less effective. C&SD intends to introduce a new strategy of Online Questionnaire System to replace the Imaging System.
