II. Matters arising

Report by the Chairman on his meeting with the Chief Secretary for Administration

2. <u>The Chairman</u> said that there was nothing special to report.

3. <u>Ms Emily LAU</u> considered it necessary to clarify with the Administration whether the Chief Executive's Question and Answer Session ("Q&A Session") on 10 December 2012 would be counted as one of the four Q&A Sessions scheduled for the current legislative session or whether it would be an additional one. <u>The Chairman</u> undertook to clarify with the Administration.

III. Further business for the Council meeting of 19 December 2012

(a) <u>Tabling of papers</u>

Report No. 8/12-13 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments (LC Paper No. CB(2) 338/12-13 issued vide LC Paper No. CB(3) 235/12-13 dated 13 December 2012)

4. <u>The Chairman</u> said that the Report covered one item of subsidiary legislation, i.e. the Import and Export (General) Regulations (Amendment of Schedule 7) Notice 2012 (L.N. 173), the period for amendment of which would expire on 19 December 2012. <u>The Chairman</u> further said that no Member had indicated intention to speak on the Notice.

6. The Chairman said that Mr LEE Cheuk-yan would move a proposed resolution under the Legislative Council (Powers and Privileges) Ordinance at the Council meeting to appoint a select committee to inquire into the unauthorized building works at the Chief Executive's properties at Peel Rise on the Peak and related issues. The Chairman informed Members that the speaking time limit for each Member at the motion debate was 15 minutes.
