Paper for the House Committee meeting on 25 January 2013

Proposal for activation of the Subcommittee on Retirement Protection under the Panel on Welfare Services

Purpose

This paper invites the House Committee to consider the proposal of the Panel on Welfare Services ("the Panel") to activate its Subcommittee on Retirement Protection ("the Subcommittee").

Background

- 2. In the Fourth Legislative Council ("LegCo"), the Panel appointed the Subcommittee on Retirement Protection ("the former Subcommittee") in January 2011 to study issues relating to the protection of retirement, and to follow up the proposal for implementation of a universal retirement protection scheme for all people in Hong Kong. The former Subcommittee completed its work and reported to the Panel in May 2012. The former Subcommittee recommended that the Government should make public all the findings of the studies conducted by the Central Policy Unit on the subject of retirement protection to facilitate public discussions; the next Government should set up a dedicated task force to study the subject matter, with a view to drawing up a concrete timetable for the launch of an extensive public consultation on the options and implementation details, and formulating concrete execution plans in the first year of tenure; and the Panel should follow up the matter in the next term.
- 3. Upon the commencement of the Fifth LegCo, the House Committee appointed the Subcommittee on Poverty in October 2012 to study policies and issues relating to poverty alleviation and to follow up the work of the Government's Commission on Poverty.

Appointment of Subcommittee on Retirement Protection

- 4. The Panel is very concerned about the provision of retirement protection for the public at large, particularly for the elderly as they cannot benefit from the Mandatory Provident Fund ("MPF") system which was launched in 2000. Members are of the view that the MPF system should be enhanced, and the provision of the Old Age Living Allowance should not be regarded as a form of retirement protection. In light of the ageing population, the Panel considers that the Government should establish a universal retirement protection system for all people in Hong Kong.
- 5. Noting that the Commission on Poverty has set up a Social Security and Retirement Protection Task Force, the Panel has considered whether the issues relating to retirement protection should be left to the Subcommittee on Poverty for follow-up or the Panel should form another subcommittee to study the issues. Having considered that the former Subcommittee had made useful recommendations for the Administration's consideration and also recommended that the Panel should follow up with the Administration on the matter in the current term, members agreed at the Panel meeting on 14 January 2013 to appoint the Subcommittee. The terms of reference, work plan and time frame of the Subcommittee is in **Appendix I**.
- 6. Members of the Panel have noted that the number of subcommittees on policy issues in operation has reached the maximum number of eight and the Subcommittee will be placed on the waiting list. They are concerned that the Subcommittee is unable to commence its work until a vacant slot arises upon the completion of work of any one of these eight subcommittees. In anticipation that fewer bills would normally be introduced into the Council during the first and second legislative sessions and the Secretariat should have the capacity to absorb the work arising from the early activation of the Subcommittee, members of the Panel have decided that the approval of the House Committee should be sought for the activation of the Subcommittee.

Consideration for activation of subcommittees

7. In accordance with rule 26(b) of the House Rules, if the number of Bills Committees in operation is less than 16, the House Committee may activate subcommittees on the waiting list after having considered the following:

- (a) the number of vacant slots for Bills Committees;
- (b) the number of bills likely to be introduced to the Council in the next three months;
- (c) the number of subcommittees on subsidiary legislation already or likely to be appointed by the House Committee and by Bills Committees; and
- (d) the availability of resources in the Secretariat.

Latest position on Bills Committees and subcommittees

Bills Committees

8. At present, two Bills Committees are in operation. Based on the 2012-2013 Legislative Programme, 13 more bills will be introduced into the Council in the current session, including five in the first half of the session. Furthermore, eight bills not on the Legislative Programme are expected to be introduced within the current session, about three of which may be introduced in the next three months. Details of the existing Bills Committees and the bills expected to be introduced into the Council in the current session are given in **Appendix II**.

Subcommittees on subsidiary legislation

9. A total of three subcommittees on subsidiary legislation are currently in operation, including one which will report its work to the House Committee at its meeting on 25 January 2013. As no ceiling is set for the formation of subcommittees to study subsidiary legislation, it is expected that at least seven such subcommittees will be formed in the next three months, including one to study the 13 sets of subsidiary legislation for the implementation of the new Companies Ordinance (28 of 2012). Of these 13 sets of subsidiary legislation, 12 sets are subject to the negative vetting procedure to be introduced into the Council in three batches in February, March and May 2013 respectively, and one set subject to the positive vetting procedure to be introduced when ready. Details of the existing and anticipated subcommittees on subsidiary legislation are in **Appendix III**.

Subcommittees on policy issues and other Council business

10. Currently, there are one subcommittee on policy issues and two subcommittees on other Council business^{Note} formed under the House Committee, and seven subcommittees on policy issues formed under Panels in operation. Two subcommittees on policy issues formed under the Panel, including the Subcommittee, are on the waiting list. A proposal has also been made for the appointment of a subcommittee under the Panel on Food Safety and Environmental Hygiene to study issues relating to public markets. Details of the subcommittees on policy issues in operation and on the waiting list and the proposed subcommittee on policy issues are in **Appendix IV**.

Advice sought

11. The House Committee is invited to consider the Panel's proposal to activate the Subcommittee.

Panel on Welfare Services

Subcommittee on Retirement Protection

Terms of reference

To study issues relating to the retirement life of all people, and to follow up on the proposal of setting up and implementation of universal retirement protection for all people in Hong Kong.

Work plan

The Subcommittee will focus its work on the following areas –

- (a) to review the exiting model for retirement protection;
- (b) to study the feasibility of setting up and implementation of universal retirement protection for all people in Hong Kong; and
- (c) to formulate, in the light of Hong Kong's ageing population, the way forward on retirement protection and issues related to their livelihood.

Time frame

The Subcommittee will, in accordance with rule 26(c) of the House Rules, complete its work within 12 months of its commencement and report to the Panel. Should the Subcommittee consider it necessary to work beyond that 12 months, it should, after obtaining the endorsement of the Panel, report to the House Committee and give justifications for an extension of the 12-month period.
