Paper for the House Committee meeting on 24 May 2013

Subcommittee on Proposed Senior Judicial Appointments

Purpose

This paper reports on the deliberations of the Subcommittee on Proposed Senior Judicial Appointments ("the Subcommittee").

Background

Constitutional and statutory provisions

2. Under Article 48(6) of the Basic Law ("BL 48(6)'), the Chief Executive ("CE") has the power and function to appoint judges of the courts at all levels in accordance with legal procedures. BL 88 prescribes that judges shall be appointed by CE on the recommendation of an independent commission, namely, the Judicial Officers Recommendation Commission ("JORC").

3. On the appointment of judges of the Court of Final Appeal ("CFA"), BL 90 provides that CE shall, in addition to following the procedures prescribed in BL 88, obtain the endorsement of the Legislative Council ("LegCo") of the proposed appointment. Having obtained the endorsement of LegCo, CE shall report such appointment to the Standing Committee of the National People's Congress for the record. BL 73(7) confers on LegCo the power and function to endorse the appointment of CFA judges. The endorsement requirement is also stipulated in section 7A of the Hong Kong Court of Final Appeal Ordinance (Cap. 484) ("CFA Ordinance").

4. Under BL 88 and the JORC Ordinance (Cap. 92), JORC is entrusted with the function of making recommendations to CE regarding the appointment of judges. As prescribed in section 3 of the Ordinance, the JORC consists of the Chief Justice of CFA ("CJ") as the Chairman, the Secretary for

Justice ("SJ") and seven members appointed by CE comprising two judges, one barrister, one solicitor and three other persons who are not connected in any way with the practice of law. CE is required by the JORC Ordinance to consult the Bar Council of the Hong Kong Bar Association and the Council of the Law Society of Hong Kong regarding the appointment of the barrister and the solicitor respectively to the JORC.

The current appointment exercise

5. In a letter dated 8 April 2013 to the Chairman of the House Committee, the Director of Administration advised that in accordance with BL 88, CE had accepted the recommendations of JORC to appoint -

- (a) the Honourable Mr Justice Joseph Paul FOK ("Mr Justice FOK") as a Permanent Judge ("PJ") of the CFA;
- (b) the Honourable Mr Justice Patrick CHAN Siu-oi ("Mr Justice CHAN") as a non-permanent Hong Kong judge ("HKNPJ") of the CFA; and
- (c) the Honourable James SPIGELMAN ("Mr SPIGELMAN") and the Honourable William GUMMOW ("Mr GUMMOW") as non-permanent judges from other common law jurisdictions ("CLNPJs") of the CFA.

Appointment of PJ to CFA

6. CFA is the final appellate court in Hong Kong hearing both civil and criminal appeals. It consists of CJ and PJs. Non-permanent judges may be invited to sit. There are two lists of non-permanent judges, namely, the list of HKNPJs and the list of CLNPJs.

7. When hearing and determining appeals, CFA is constituted by five judges, namely, CJ (where he is not available to sit, he designates a PJ to preside), three PJs (where a PJ is not available, CJ nominates a HKNPJ to sit in his place), and one HKNPJ or CLNPJ. From 1997, apart from very few exceptions, the "fifth judge" has invariably been drawn from the list of CLNPJs to hear a substantive appeal.

8. Under section 12(1A) of the CFA Ordinance, a person shall be eligible to be appointed as a PJ if he is -

- (a) the Chief Judge of the High Court ("HC");

- (b) a Justice of Appeal ("JA");
- (c) a judge of the Court of First Instance ("CFI"); or
- (d) a barrister who has practised as a barrister or solicitor in Hong Kong for a period of at least 10 years.

9. As a PJ vacancy will arise on 21 October 2013 when Mr Justice CHAN, PJ, vacates his judicial office upon reaching the normal retiring age of 65 years and proceeds on pre-retirement leave, the JORC has held a meeting in the first quarter of 2013 to consider recommending a person to be appointed as PJ to fill the vacancy. The JORC recommended the appointment of Mr Justice FOK, a JA of the Court of Appeal of the HC, as a PJ of the CFA with effect from 21 October 2013.

Appointment of non-permanent judges to the CFA

10. At present, there are 15 non-permanent judges comprising five HKNPJs and 10 CLNPJs. The list of five HKNPJs comprises four HKNPJs who are retired judges of the CFA or the Court of Appeal of the HC, and one HKNPJ who is a serving judge of the Court of Appeal of the HC. The list of 10 CLNPJs comprises the current President and two serving Justices of the Supreme Court of the United Kingdom ("UK") and seven retired judges from the UK, Australia and New Zealand ("NZ").

11. Section 12(3) of the CFA Ordinance provides that a person shall be eligible to be appointed as a HKNPJ if he is -

- (a) a retired Chief Judge of the HC;
- (b) a retired Chief Justice of the CFA;
- (c) a retired PJ of the CFA;
- (d) a JA or retired JA; or
- (e) a barrister who has practised as a barrister or solicitor in Hong Kong for a period of at least 10 years,

whether or not he is ordinarily resident in Hong Kong.

12. Section 12(4) of the CFA Ordinance provides that a person shall be eligible to be appointed as a CLNPJ if he is -

- (a) a judge or retired judge of a court of unlimited jurisdiction in

either civil or criminal matters in another common law jurisdiction;

- (b) a person who is ordinarily resident outside Hong Kong; and
- (c) a person who has never been a judge of the HC, a District Judge or a permanent magistrate, in Hong Kong.

HKNPJs

13. The JORC noted that the existing number of HKNPJs at five is small, which does not allow sufficient flexibility in listing appeals. In addition, having regard to his administrative duties, it is not practicable for CJ to sit in all the CFA cases. Moreover, having regard to the need to avoid possible conflict of interest, CJ does not hear any appeals from those cases in which Madam Justice Maria Candace YUEN (the spouse of CJ), a JA, has sat. As Mr Justice CHAN will become eligible to be appointed as a HKNPJ under section 12(3) of the CFA Ordinance on 21 October 2013 by virtue of being a retired PJ and noting that Mr Justice CHAN is a judge of the highest quality and utmost integrity, the JORC proposed appointing Mr Justice CHAN as a HKNPJ of the CFA.

CLNPJs

14. The JORC noted that with one of the 10 CLNPJs, The Right Honourable The Lord NEUBERGER of Abbotbury, unlikely to be available to sit on a frequent basis in the foreseeable future, the CFA will be effectively operating with only nine CLNPJs. These nine CLNPJs comprise two serving Justices of the UK Supreme Court and seven retired judges. All of them have extensive professional commitments. The retired judges have various commitments including arbitration, mediation and/or lecturing work for which they are in huge demand, not to mention that they all also have personal and family commitments. The JORC considered that because of their various commitments, the availability of the 10 CLNPJs to come to Hong Kong for four weeks to sit is somewhat limited. Against this background and noting that it is important that substantive appeals are heard within a reasonable time, the JORC proposed appointing Mr SPIGELMAN and Mr GUMMOW as CLNPJs of the CFA. If appointed, the total number of CLNPJs will be increased to 12.

The Subcommittee

15. In accordance with the LegCo procedure for endorsement of judicial appointments under BL 73(7), which was endorsed by the House Committee in

May 2003, the House Committee formed a subcommittee to consider the proposed senior judicial appointments at its meeting on 12 April 2013.

16. Under the chairmanship of Hon Dennis KWOK, the Subcommittee has held one meeting with the Administration and the Judiciary Administrator in her capacity as Secretary to JORC to discuss the proposed senior judicial appointments and related issues. The membership list of the Subcommittee is in **Appendix I**.

Deliberations of the Subcommittee

Appointment of PJ of the CFA

17. The Subcommittee received a letter from a member of the public requesting the Subcommittee to hold a public hearing on the appointment of Mr Justice FOK as a PJ of the CFA. Hon Paul TSE does not see the justification for inviting Mr Justice FOK to come before the Subcommittee to answer questions from members, unless there is reasonable ground to believe that Mr Justice FOK is not an appropriate candidate for appointment. Hon Martin LIAO has strong reservation about deviating from the established practice of senior judicial appointments. The Chairman reiterated the general principle of endorsement by LegCo.

18. Whilst Hon Emily LAU would not insist on inviting judicial appointees to come before the Subcommittee to answer questions from members, before recommending the appointments to the House Committee for endorsement by LegCo, Ms LAU is of the view that the judicial appointment process of Hong Kong should be made more transparent for better public scrutiny. Members generally agree with Ms LAU's views. Dr Hon Priscilla LEUNG also considers that there is room to improve the transparency of senior judicial appointments by, say, making the criteria for appointment clearer.

19. In view of the fact that Mr Justice FOK was only appointed JA of the Court of Appeal of the HC on 1 February 2011, some members have enquired about the criteria adopted by the JORC for recommending Mr Justice FOK as PJ of the CFA.

20. The Secretary to JORC has advised that the JORC made recommendations on judicial appointments in accordance with BL92 which provides that judges of the Hong Kong Special Administrative Region shall be chosen on the basis of their judicial and professional qualities. A summary of the JORC's deliberations on the appointment of judges to the CFA is set out in

Annexes D to F to the letter dated 8 April 2013 from the Director of Administration to the Chairman of the House Committee of LegCo and copied to all other LegCo Members.

21. At the request of the Subcommittee, the Judiciary has provided (i) information on the number and type of cases heard as well as the judgements made by Mr Justice FOK during his tenure as a Recorder of the CFI of the HC, a Judge of the CFI of the HC and a JA of the Court of Appeal of the HC respectively; and (ii) information on the length of judicial experience as well as the age of the judges appointed as PJs of the CFA since 1997 in **Appendices II and III** respectively.

22. In response to members' enquiry as to whether the information requested in paragraph 21 above had been provided to the JORC, the Secretary to JORC has advised that all information which would help the JORC to consider the appointments to the CFA had been provided to the JORC.

Appointment of CLNPJs of the CFA

23. Whilst noting that Mr SPIGELMAN and Mr GUMMOW recommended by the JORC as CLNPJs of the CFA are judges of considerable eminent standing and reputation, a member has asked whether the JORC had taken into consideration of the fact that Mr SPIGELMAN and Mr GUMMOW are aged 67 and 70 respectively.

24. The Secretary to JORC has pointed out that there is no retirement age for CLNPJs of the CFA under the CFA Ordinance. The JORC is fully aware of the age of Mr SPIGELMAN and Mr GUMMOW. The reason why many CLNPJs of the CFA are persons of advanced age is because CLNPJs of the CFA are from such common law jurisdictions as the UK, Australia and NZ and judges from Australia and NZ are allowed to take up judicial posts in other jurisdictions only after they have retired.

25. A member opines that judges from the UK are generally more conservative than those from Australia. The member hopes that CLNPJs of the CFA comprises a balanced mix of judges of conservative and liberal beliefs, having regard to the fact that both Mr SPIGELMAN and Mr GUMMOW are Australian.

26. The Secretary to JORC has pointed out that CLNPJs of the CFA are judges from the UK, Australia and NZ. Information on the respective jurisdictions of judges currently serving as CLNPJs of the CFA is in **Appendix IV**.

27. As CLNPJs of the CFA do not ordinarily reside in Hong Kong, concern was raised that their consideration of cases may be compromised by their lack of understanding of the local context.

28. The Secretary to JORC has responded that there is no cause for such concern as the CFA, being the final appellate court in Hong Kong, deals with points of law. Sufficient information would be provided to CLNPJs to help them understand relevant facts and the actual situation in Hong Kong where necessary.

Mechanism for handling complaints against judges

29. A member urges the Judiciary to review its existing mechanism for handling complaints against judges, as LegCo Members have from time to time received complaints from members of the public who are aggrieved by the decisions of the Judiciary concerning their complaints against judicial conduct.

30. The Judiciary has advised that all complaints against judicial conduct are handled by the CJ and/or the relevant Court Leaders as appropriate, and the mechanism is made known to the public on the website of the Judiciary and in the information leaflets placed at all Judiciary premises for public collection. If the complaints are against judicial decisions made by judges, the complainants would be advised to pursue his case by appeal through the existing legal procedures.

Membership of SJ in the JORC

31. Question was raised about the appropriateness of SJ, being one of the Principal Officials under the Political Appointment System, to be a member of the JORC.

32. The Administration considers it appropriate and necessary for SJ to be involved, as one of the nine members of the JORC, in judicial appointments. SJ is the guardian of public interest in the administration of justice and upholder of the rule of law. The Administration reiterates its position that the membership of SJ in the JORC would not undermine the independence of the JORC. SJ, being the principal adviser on legal matters to the CE and the head of the Department of Justice, a major user of the court, is in a unique position and has considerable knowledge to contribute to the JORC's deliberations in respect of judicial appointments. Such a view is also shared by the Judiciary.

The proposed senior judicial appointments

33. Members have considered the curriculum vitae of the four recommended appointees covering various aspects including personal background, education, legal experience, judicial experience, services and activities, publications and awards. Members note that all four recommended appointees have profound judicial experience and are judges of high standing and reputation. The Subcommittee supports the proposed appointments of Mr Justice FOK as a PJ of CFA, Mr Justice CHAN as a HKNPJ of CFA and Mr SPIGELMAN and Mr GUMMOW as CLNPJs of CFA. The Subcommittee has no objection to the Administration giving notices for moving motions to seek the endorsement of LegCo of the recommended appointments.

Advice sought

34. Members are invited to note the deliberations of the Subcommittee.
