Appointment of a subcommittee to prepare for the operation of the select committee to which the petition presented at the Council meeting of 8 May 2013 has been referred

Purpose

This paper invites Members to consider the appointment of a subcommittee to prepare for the operation of the select committee to which the petition presented at the Council meeting of 8 May 2013 has been referred.

Background

2. At the Council meeting of 8 May 2013, Hon Dennis KWOK presented a petition jointly signed by Hon Cyd HO and himself (**Appendix I**). The request of Hon Cyd HO for the petition to be referred to a select committee was supported by 25 Members. The petition has thus been referred to a select committee under Rule 20(6) of the Rules of Procedure ("RoP").

Relevant rule and practices

3. Under Rule 78(2) of RoP, the President shall decide the size of every select committee and shall appoint the chairman, deputy chairman and members thereof, taking into account the recommendations of the House Committee. Since the First Legislative Council ("LegCo"), the Council has appointed by resolution a total of five select committees. In

Apart from providing for the appointment of a select committee to inquire into or study the relevant matters, the respective resolution also provided that in the performance of its duties, the select committee be authorized under section 9(2) of the Legislative Council (Powers and Privileges) Ordinance (Cap. 382) to exercise the powers conferred by section 9(1) of

respect of three of these select committees, the House Committee appointed respective preparatory subcommittees to undertake preparatory work for the setting up of the select committees. The preparatory work mainly included drawing up the wording of the motion to be moved in the Council on the appointment of a select committee to inquire into or study the relevant matters, the membership size of, and the procedure for nomination and election of Members for appointment to the select committees. Details of the select committees and preparatory subcommittees are set out in **Appendix II** and **Appendix III** respectively.

- 4. In the case of the Select Committee on Building Problems of Public Housing Units for which no preparatory subcommittee was set up by the House Committee, the proposal to set up the select committee was made by the Panel on Housing. Before the proposal was submitted to the House Committee for consideration, the Panel had set up a working group to draw up the terms of reference ("TOR") of the proposed select committee. The House Committee discussed the Panel's proposal at two meetings, and agreed on the setting up and scope of inquiry of the select committee at the second meeting. The House Committee considered and agreed on the membership size of and nomination of Members for appointment to the select committee at two subsequent meetings.
- 5. As regards the Select Committee to Study Mr LEUNG Chunying's Involvement as a Member of the Jury in the West Kowloon Reclamation Concept Plan Competition and Related Issues, the House Committee agreed to set up the select committee at its special meeting on 24 February 2012. As the House Committee considered it necessary to expedite the formation of the select committee in order that the inquiry could be completed within the very tight timeframe, the House Committee did not appoint a preparatory subcommittee on that occasion. Instead, the House Committee decided the TOR of the select committee at the special meeting on 24 February 2012, and agreed on the membership size of and the nomination of Members for appointment to the select committee at the following meeting on 2 March 2012.
- 6. It is an established practice that upon commencement of operation, a select committee would determine the major areas of study, the work plan and the practice and procedure of the select committee.

Recommendation

7. Having regard to the arrangements for setting up select committees in the past and the fact that it is the first time that a select

committee is formed pursuant to Rule 20(6) of RoP, it is recommended that a subcommittee be appointed by the House Committee to undertake preparatory work for the operation of the select committee, including drawing up the TOR to reflect the substance of the petition, the membership size and the nomination procedure in respect of the select committee.

8. Members are invited to endorse the recommendation set out in paragraph 7 above.

儘管立法會政府帳目委員會將會跟進審計署有關廉署的衡工量值報告,以 及行政長官梁振英成立了「廉政公署公務酬酢、餽贈及外訪規管制度和程 序獨立檢討委員會」,惟均無法全面跟進湯顯明先生的外訪、宴請及送禮 事宜。因此,我們懇請各位議員支持此呈請書,以挽回廉署的威信及形象, 重彰香港廉潔奉公的核心價值。
