Subcommittee on Mediation Ordinance (Commencement) Notice

Purpose

This paper briefs Members on the progress of the establishment of the non-statutory, industry-led accrediting body for mediators.

Background

- 2. At present, mediators practising in Hong Kong are mostly accredited by the Hong Kong International Arbitration Centre ("HKIAC"), the Law Society of Hong Kong ("the Law Society") and the Hong Kong Mediation Centre ("the Mediation Centre"). A summary of the training and accreditation requirements of these three accreditation bodies is at **Annex**.
- 3. The establishment of a single body for accrediting mediators was considered desirable by the Working Group on Mediation¹ ("the Working Group") and was one of the recommendations in the Report of the Working Group ("the Report") published in February 2010². Nonetheless, the Working Group noted that "the time [was] not right to prescribe a standardized system of accrediting mediators ³" and recommended that the possibility of establishing such a body be reviewed in five years⁴. However, the majority of the submissions received

during public consultation urged that a single accreditation body be set up as soon as possible.

Establishment of a non-statutory, industry-led accreditation body

- 4. Based on the recommendations of the Working Group, the Secretary for Justice's Mediation Task Force⁵ and the Accreditation Group under it worked with the major mediation stakeholders with a view to facilitating the establishment of a non-statutory, industry-led accreditation body for mediators. The Administration has kept the Bills Committee on Mediation Bill informed about the progress of its establishment⁶.
- 5. The non-statutory, industry-led accreditation body, Hong Kong Mediation Accreditation Association Limited ("HKMAAL") (香港 調解資歷評審協會有限公司), a company limited by guarantee, was incorporated on 28 August 2012. The four founder members of HKMAAL are the Hong Kong Bar Association, the Law Society, HKIAC and the Mediation Centre. These four professional bodies are the major stakeholders and their members are closely involved in the development and promotion of mediation in Hong Kong.

6. The objects of HKMAAL are –

- (a) to set standards for accredited mediators, supervisors, assessors, trainers, coaches and other professionals involved in mediation in Hong Kong, and to accredit them on satisfying the requisite standards;
- (b) to set standards for relevant mediation training courses in Hong Kong, and to approve them on satisfying the requisite standards; and
- (c) to promote a culture of best practice and professionalism in mediation in Hong Kong.

The Mediation Task Force was set up in December 2010 to consider and implement the recommendations in the Report of the Working Group on Mediation.

- 7. Following its incorporation, representatives of the founder members of HKMAAL conducted a briefing on 11 October 2012 for stakeholders to explain its objectives and functions and to collate their views. Organizations and individuals who had submitted views to the Bills Committee on Mediation Bill were invited to attend the briefing.
- 8. Being an industry-led body, HKMAAL works independently in its operation. The Administration notes that HKMAAL is now working on matters including (i) the admission of members to HKMAAL; (ii) formulation of an accreditation system, grandparenting policy and procedure and standards for mediation training courses; and (iii) establishment of a complaint and disciplinary procedure.
- 9. The Administration will continue to monitor the accreditation and training of mediators in Hong Kong.
