## Subcommittee on Import and Export (General) (Amendment) Regulation 2013

With regard to the questions raised by the Subcommittee at its meeting on 25 March, our reply is as follows:

#### (1)Provision of receptacles for disposal of powdered formula

The Food and Health Bureau, the Customs and Excise Department and stakeholders of boundary control points are working to arrange the provision of receptacles at passenger departure hall, coach drop-off area and vehicle holding area of the control points for persons leaving Hong Kong to dispose of their excessive powdered formula before immigration clearance. The Government has initially identified suitable locations for provision of receptacles at 9 boundary control points. In the meantime, the Government has also liaised with several non-governmental organisations (NGOs) operating the Short-term Food Assistance Service Projects to learn about their interest in collecting the

powdered formula concerned. The Administration is arranging a meeting with these NGOs and relevant stakeholders in early April to further discuss the proposal.

## (2) Information on the powdered formula export licenses
