Exemption ("CoE") and those which had not been issued with a licence or CoE because of not meeting the licensing requirements; and

- (b) response to issues of concern raised at the meeting of the Panel on Welfare Services on 16 April 2013 when the subject of implementation of the licensing scheme for RCHDs was discussed.
- 4. <u>Members</u> agreed to receive public views on the Residential Care Homes (Persons with Disabilities) Ordinance (Commencement) Notice 2013 ("the Commencement Notice") at the next Subcommittee meeting.
- 5. <u>Members</u> further agreed that to allow more time for the Subcommittee to study the Commencement Notice, the Chairman of the Subcommittee would give notice to move a motion at the Council meeting of 8 May 2013 to extend the scrutiny period of the Commencement Notice to 5 June 2013.
