- 3. <u>The Administration</u> was requested to provide written responses to the following issues raised by members at the meeting -
 - (a) written responses to Ms Cyd HO's suggestion that the length of the proposed validity period should be shortened, and her view that it would not suffice to require only the appointed person to submit photographs showing the physical condition of the building works involved for the purpose of validation under the proposed Signboard Control System;
 - (b) written responses to Mr Tony TSE's suggestion that the validation applicant should be required to provide information on the purchase of insurance for the signboard concerned, property ownership and any other information that might be deemed necessary in the application form for joining the validation scheme; and
 - (c) information on the manpower of the Buildings Department.

4. <u>Members</u> agreed to extend the scrutiny period of the Building (Minor Works) (Amendment) Regulation 2013 ("Amendment Regulation") and Building Legislation (Amendment) Ordinance 2012 (Commencement) Notice ("Notice") to 17 July 2013.

The Notice provides for the commencement of the relevant provisions on 2 September 2013.

Mr Kwok's enquiry as to why the Administration did not take timely enforcement actions to remove unauthorized signboards but to allow the existence of unauthorized signboards by introducing SBCS, under which the continued use of the existing unauthorized signboards would be allowed after validation and subject to a periodic safety inspection at an interval of five years (i.e. 5-Year Validity Period).

		The Administration's explanation that taking into account that most of the 120 000 existing unauthorized signboards were in active use by business operations and did not pose immediate danger, and the Building Department ("BD") would take enforcement actions according to the priority against the large number of unauthorized signboards with the existing manpower resources, the Administration sought to deal with the issue of unauthorized signboards in a pragmatic way by introducing SBCS in a way similar to that for prescribed building or building works (i.e. household amenity features covering unauthorized small canopies, drying racks and supporting frames for air-conditioners) under MWCS which came into operation on 31 December 2010.	
		Responding to Mr Kwok about the inspection method against unauthorized signboards, the Administration advised that most of the unauthorized signboards that posed danger to the public could be dealt with during the following inspections/operations carried out by BD -	
		(a) the physical conditions of signboards that constitutes obvious hazard or imminent danger could be assessed by way of visual inspection for necessary action in response to the reports from the public;	
		(b) signboards with signs of structural defects would be identified and tackled during the yearly large-scale operations carried out in districts with heavy traffic and large number of signboards; and	
		(c) continuous operations would be conducted to remove abandoned signboards in an efficient manner upon reports from the public, including the district councils.

		The Administration's responses that -	
		(a) according to the previous estimation, there were about 190 000 unauthorized signboards in Hong Kong. During the stock-taking exercise of unauthorized building works ("UBWs") covering unauthorized signboards erected at the exterior of the buildings conducted in the past two years by consultants engaged by BD, it was reported that there were about 120 000 unauthorized signboards in Hong Kong at present;	
		(b) the consultants engaged for the stock-taking exercise had collected information about the physical conditions of the signboards such as the type, location and photograph of the signboards but no information had been sought on the ownership of these signboards;	
		(c) BD was in the course of analyzing the substantial amount of data collected for compilation of the database on these signboards;	
		(d) under SBCS, information such as location, size, and ownership of unauthorized signboard would be required to be submitted for validation. BD would then have the information on the whereabouts of those validated signboards and could take appropriate action against them if they had not undergone the 5-year periodic safety inspection; and

The Chairman's view that the information about the ownership of unauthorized signboards could be collected through the validation scheme to facilitate the compilation of a database on these signboards.	
		The Administration advised that under the proposed SBCS, BD would notify the relevant owners' corporation ("OC") concerned (if an OC had been formed) about the application for validation of the existing unauthorized signboards situated in the common parts of their buildings.

While there was no requirement on the minimum vertical clearance between signboards, two adjacent projecting signboards should have a minimum lateral clearance of 2.4m. Most of the existing signboards in Hong Kong could meet such requirement.

		The Administration's responses that -	
		(a) BD would review SBCS two years after its operation, including the number of applications received, the difficulties in processing the applications and the adequacy of the manpower resources to implement the scheme;	
		(b) regarding issues relating to property ownership and the purchase of the insurance for the signboard concerned, the Administration would consider whether reminders on the above issues could be put down in the application forms or other promotional materials to alert the applicants of their responsibility;	
		(c) consideration would be given to highlighting in the relevant practice notes the need for the industry to observe the requirements set out in the Guidelines on Industry Best Practices for External Lighting Installations issued by the Environmental Bureau in planning installation of signboards;	
		(d) taking into account the financial burden imposed on the signboard owners to conduct the periodic safety inspection frequently and the normal lifespan of these signboards, the Administration considered it appropriate to set the validity period at an interval of five years; and	
		(e) although there were no specific timeframes for completing the validation and enforcement actions, BD would try its best to tackle unauthorized signboards with the available resources.

		The Administration's explanation that -	
		(a) under the proposed section 62A(4)(b), "the description showing the physical condition of the signboard" would also cover building plans and structural calculations that had to be submitted for validation under SBCS; and	
		(b) the details of the documents required to be submitted for validation would be set out in the technical guidelines and specified forms, etc.	
		The Administration was requested to provide written response to the views and suggestions of Ms HO regarding the Validity Period and the information required to be submitted for validation.	Admin (paragraph 4 of the minutes)

		(a) breakdown on different kinds of unauthorized signboards would be further worked out after the completion of its analysis on the data collected during the stock-taking exercise on UBWs;	
		(b) erection of large size signboards would require the prior approval of BD of plans and consent to the commencement of building works. As they did not fall within the technical specifications of MWCS to be adopted by SBCS, they were not eligible for joining the validation scheme. Enforcement actions would be taken against large size signboards erected without approval;
