The Administration considered that the two issues should be followed up in the context of the Building Management Ordinance (Cap. 344) ("BMO"). Nevertheless, BD would take the initiative to notify the Owners' Corporations ("OCs") about the application for erection of new signboards/application for validation of unauthorized signboards to facilitate the communication between the signboard owners and building owners;	
		(b) BD would allow the continued use of certain existing unauthorized signboards after validation under SBCS and would not take enforcement actions against them but these signboards would remain as unauthorized building works;	
		(c) since signboards belonging to the Class I category were always displayed at prominent location with relatively larger projecting size, the Administration considered that the minor works relating to Class I signboards under the validation scheme should be carried out by the building professionals who were registered for the corresponding class concerned. The signboard owners would have to bear the cost for removal which might be much higher than the cost of strengthening the signboards for the purpose of validation;	
		(b) the building owners might resort to civil litigation if necessary to resolve the disputes arising from erection of signboards at their buildings without their consent; and	
		(c) application could be made under MWCS for replacement of display area of signboards. In accordance with the "Practice Note for Authorized Persons, Registered Structural Engineers and Registered Geotechnical Engineers" on MWCS ("APP-147"), minor works submission numbers or BD reference numbers were recommended to be displayed on signboards erected or altered under the simplified requirements of MWCS and signboards erected or altered with prior approval and consent from the Building Authority respectively so as to distinguish them from unauthorized signboards.

		Responding to Mr CHAN's enquiry about the recovery of cost of removing signboards by BD, the Administration advised that in some cases, BD was not able to recover the cost of removing the abandoned signboards because the signboard owners could not be found in such cases and BD did not keep statistics relating to cost recovery for removal of signboards. Nevertheless, BD would make use of the information on signboard owners collected under the validation scheme of SBCS and follow up with the owners concerned on the removal of abandoned signboards and recovery of cost.
