2013 Provisional Registers of Electors and Related Matters

INTRODUCTION

This paper briefs Members on the key statistics relating to the 2013 Provisional Registers ("PR") of electors, as well as the Administration's views on the suggestion by a Legislative Council ("LegCo") Member on the use of the personal data contained in the electoral register and email addresses of electors by LegCo Members for communication with their constituents after the LegCo election.

2013 PROVISIONAL REGISTERS OF ELECTORS

2. Following the deadline for voter registration ("VR") on 16 May 2013, the 2013 PR of electors and omissions lists¹ ("OL") were released by the Registration and Electoral Office ("REO") on 14 June for public inspection. A copy of the press release is at **Annex A**. Registered electors who have changed their residential addresses or other registered particulars were reminded to fulfill their civic responsibility by notifying the REO by 29 June so that the REO could update their records accordingly. The Final Registers ("FR") of electors will be published on or before 25 July. Key statistics of the 2013 PR and a few observations are set out in the ensuing paragraphs.

Geographical Constituencies ("GCs")

Newly registered electors

3. There are about 3.47 million registered electors contained in the 2013 PR of electors for geographical constituencies, representing a registration rate of 73.1%. Amongst these electors, about 56 000 are newly registered. About 53 000 electors are proposed to be deleted in the FR, of which about 25 000 electors are those who have passed away and about 28 000 electors are those who have failed to update or confirm their latest residential addresses in response to the REO's inquiry letters. The total figure represents a net increase of more than 3 000 electors when compared with the 2012 FR.

The omissions lists contain electors who have passed away or the electors who have failed to update or confirm their latest residential address in response to the Registration and Electoral Office's inquiry letters.

While the registration rate is slightly lower than past election years in 2011 (75.6%) and 2012 (73.6%), it is consistent with the performance in previous non-election years which usually see a small dip in the overall voter registration rate after a cycle of major elections. For example, the provisional registration rate of 73.1% is comparable to the overall rates in 2009 and 2010, which are 72.1% and 73.2% respectively. According to past experience, the overall registration rate in a non-election year is usually lower as there is no election to boost people's incentive to register as electors.

Registration rates of different age groups

- 5. One of the Administration's objectives in the 2013 VR campaign is to encourage more young people to register as electors. To this end, the REO continued to disseminate the VR message to the public through social media, in addition to the traditional publicity channels, in order to reach out to young people. For instance, flash banner advertisements were placed on some popular websites² patronized by youth.
- As a result of the publicity efforts over the years, the registration rates of eligible young people aged 18-30 have edged up steadily from 50.7% in 2007 to about 60% in recent registration cycles. For the 2013 PR, although the registration rate of this age group has dropped slightly to 59.2%, it stays at a level comparable to that in 2012 (61.2%) and 2011 (60.0%).
- 7. The registration rates of electors of other age groups are on average over 75% and relatively stable. Further details of the age and sex profile of registered electors of different age groups by LegCo Constituencies and Districts in 2013 are set out in the tables at **Annex B**.

De-registration of electors

8. The number of registered electors requesting deletion of electoral records after the implementation of the enhanced checking and improvement measures on the VR in 2012 has increased compared with previous election and non-election years. In 2012, the number rose sharply to 1 900 from about 190 in 2011. In 2013, while the number dropped to around 470, it is still more than double that in 2009 (210) and 2010 (190) respectively.

9. While registered electors are not legally bound to disclose to the REO their reasons when requesting deletion, according to our understanding, one of the reasons is the inconvenience brought by the enhanced checking measures to registered electors. The inconvenience in this regard is to a large extent unavoidable, given the statutory procedures required of the inquiry process under the electoral law. The REO has already adopted a more prudent approach when implementing the enhanced checking measures to avoid causing too much inconvenience to registered electors and their relatives as far as practicable. Since VR is voluntary, we reckon that these measures may have, to a certain extent, affected the incentive of eligible persons to register as electors, and for registered electors to maintain their registration status.

<u>Updating of registration particulars</u>

- 10. Similar to the case of new registration, usually fewer applications for updating registered particulars are received in a non-election year immediately following a cycle of major elections. Furthermore, given that over 610 000 updating cases have already been handled during the 2011 and 2012 election cycles, we do not expect a large number of updating cases this year. Up to 29 June 2013, about 113 000 applications for updating registration particulars from registered electors were received by the REO. The number of updating cases received in 2009 and 2010 is also around 100 000 each year.
- 11. To address the phenomenon that registered electors often fail to update their particulars after moving their residence, the REO will continue to strengthen its publicity efforts to encourage registered electors to update their registration particulars in a timely manner in future VR drives.

Functional Constituencies ("FCs")

Traditional FCs

12. For the 2013 PR for traditional FCs, the number of registered electors is about 238 000, of which about 1 000 electors are newly registered and some 1 400 electors have changed to register under the District Council (second) FC. On the other hand, there are about 2 300 electors put into the OL³. As a result, the number of traditional FC electors in the 2013 PR represents a net decrease of about 2 800 electors

compared with the 2012 FR.

District Council (second) FC

- 13. The number of registered electors of the District Council (second) FC in the 2013 PR is about 3.22 million, representing a decrease by around 250 electors when compared with the 2012 FR. Among these 3.22 million electors, about 50 500 are newly registered GC electors, 800 existing GC electors in the 2012 FR who have applied for registration as electors in the District Council (second) FC and some 1 400 electors in the 2012 FR who have switched from other FCs. Separately, in the 2013 PR, there are also about 50 400 electors put onto the OL⁴, about 2 000 GC electors who were also electors of District Council (second) FC in the 2012 FR who have decided not to be registered as electors in this FC again and some 200 electors switching to other FCs.
- 14. A table showing the distribution of registered electors by FCs (other than District Council (second) FC) in 2013 is at <u>Annex C</u>. Other statistical information is available at the VR website www.voterregistration.gov.hk.

USE OF ELECTORAL REGISTER

15 her letter dated 5 June 2013 [LC Paper CB(2)1340/12-13(01)], a LegCo Member raised the issue on the use of the information contained in the electoral register and the email addresses of electors by incumbent LegCo Members for the purpose of communicating with electors in their constituencies after the LegCo election and asked the Government to consider sending out the electronic version of the work reports of LegCo Members to electors to save the use of paper and printing/postage cost. The letter was referred to the Panel on Constitutional Affairs ("the Panel") for follow-up. Similar proposed uses of electoral register were last discussed by the Panel at its meetings on 19 November 2007 and 18 February 2008.

Use of electoral register under the existing law

16. The electoral register contains the full names and residential addresses of all registered electors and the use of such information is governed by the relevant electoral law for the VR.

- 17. According to the relevant Electoral Affairs Commission ("EAC") Regulations ⁵ under the EAC Ordinance (Cap. 541), the Electoral Registration Officer ("ERO") may make available extracts of register for any purpose related to an election to any person that the ERO considers appropriate. When making available an extract of the register, the ERO must specify the particular election for which it may be used. A person to whom an extract is made available must not use the information on the register for a purpose other than a purpose related to the specified election.
- 18. The EAC Regulations further provide that it is an offence to use any information relating to a person contained in a register or an extract from a register for a purpose other than a purpose related to an election. Any person who commits the said offence is liable to a fine up to HK\$5,000 and imprisonment for 6 months.⁶
- 19. For the email addresses of electors, the information is provided by electors on a voluntary basis only for the purpose of receiving election advertisements in elections and is not part of the electoral register. The information is kept by the REO and will be provided to candidates for communication with electors when there is an election. At present, about 414 000 electors, representing nearly 12% of electors in the 2013 PR, have provided their email addresses to the REO.
- As stated in the personal information collection statement in the application form for VR, the personal data and other related information so provided by an applicant will be used by the REO for "VR and election related purposes". Such information may also be provided to other authorized departments/organizations/persons for the purpose of "VR and election under the relevant Ordinances and/or subsidiary legislations and all purposes related thereto".
- Since email addresses are not information contained in an electoral register, their use and disclosure are not governed by the relevant EAC Regulations. Nonetheless, they are governed by the Personal Data (Privacy) Ordinance (Cap. 486) ("PDPO") and any

applicable privacy statement concerning the use and disclosure of information by the REO.

The Administration's views

- 22. The Administration's views on the matter were set out in a paper to the Panel in November 2007 [LC Paper No. CB(2)338/07-08(05)] and explained to Members at separate Panel meetings held on 19 November 2007 and 18 February 2008 respectively.
- 23. The Administration appreciates the importance for LegCo Members to maintain regular communication with electors in their constituencies to keep the latter informed of their work. In fact, the Administration has been providing resources to LegCo Members to help them communicate with their constituents and facilitate their work. example, LegCo Members have already been provided with about \$2.17 million on reimbursement basis to cover operating expenses arising out of their LegCo duties each year. Items of reimbursable expenses include, but not limited to, printing of newsletters relating to LegCo business, communication charges (including postage for bulk mailing, Internet, telephone and fax charges), website expenses, publicity items (such as items publicizing Members' websites, social websites and email addresses for the purpose of conducting LegCo business), secretarial/staffing office accommodation expenses (including rentals, rates, government rents, management fees and utility charges), etc.
- 24. In essence, when considering the proposal for the Administration to relax the use of electoral register by LegCo Members and provide email addresses of electors to LegCo Members for non-election related purposes, due regard should be given to the legal parameters, including the protection of personal data and privacy of electors, as well as the policy commitment to safeguarding the principle of fair, open and just elections.

Safeguarding the principle of fair, open and just elections

25. If we were to allow LegCo Members to use the information contained in the electoral register and email addresses of electors for purposes other than a purpose related to an election, we will need to amend existing legislative provisions as explained in paragraphs 17 and 18 above. In doing so, we will also need to address possible concerns by individuals who may be interested in running for future elections and would ask for the same personal particulars and contact information to facilitate their early contact with these constituents. Otherwise, there

could be complaints that the exclusive "facilitation" would give an undue advantage to incumbent LegCo Members.

As mentioned in paragraph 23 above, incumbent LegCo Members have been given resources to facilitate their work and communication with their constituents. Hence, the Administration has to strike a careful balance in considering any additional arrangements that may be perceived as giving incumbent LegCo Members further advantages which may have an impact on the fairness of election.

Protecting the personal data and privacy of electors

- 27. The relevant provisions in the EAC Regulations mentioned in paragraphs 17 and 18 above aim at striking a balance between two essential considerations, i.e. the need to provide basic information on electors to relevant parties (such as candidates and the political groups or parties which support them) to facilitate the planning and conduct of election-related activities on the one hand, and the need to protect personal data and the privacy of electors on the other hand.
- As regards the email addresses kept by the REO, the information is provided by electors for the sole purpose of receiving election advertisements from candidates during elections. In the absence of the express consent of electors otherwise, it will be in breach of the PDPO to permit the use of the information for a purpose other than the one for which the relevant data have been collected.
- As a matter of fact, there has been rising concern of electors about the use of their personal data for canvassing and its misuse for other non-election related purposes by candidates and other third parties. Therefore, any proposal to amend the existing law to allow LegCo Members to use the personal data of electors in the register and their email addresses for non-election related purposes will be highly controversial and require careful consideration. We should also be mindful of any potential adverse impacts on the VR campaign brought by such changes.

Other electronic means to contact electors

30. Apart from using the email addresses of electors, LegCo Members have been communicating with their constituents via effective social media channels such as personal Homepage or Facebook, which also serve as an environmentally friendly means to help save paper and printing/postage cost. Furthermore, as mentioned in paragraph 23 above, communication charges, website expenses and publicity items are all reimbursable. In fact, individual LegCo Members' websites, their email addresses, as well as their office addresses and telephone numbers are included in the LegCo Members' Contact Directory, which is available at the LegCo's homepage and easily accessible by the public. Hence, it is unlikely that the day-to-day communication between LegCo Members and their constituents will be much hampered even if the REO does not provide the email addresses of electors for non-election related purposes.

Views of the EAC

- 31. The existing statutory provisions governing the compilation and use of the electoral register are made by the EAC for the purpose of conducting elections. In this regard, the Administration undertook to relay the views expressed by Members at the Panel meetings held in November 2007 and February 2008 to the EAC for consideration.
- The EAC notes that the existing electoral legislation has 32. been drawn up primarily to facilitate the conduct and supervision of elections. The proposal to relax the existing restrictions on the use of the personal data in the electoral register is not directly related to this purpose and, therefore, should be a policy issue outside the context of elections, after weighing all relevant considerations and taking into account public views. Nonetheless, given the ever rising concern of electors about the use of their personal data, the EAC sees the need to adopt a prudent approach when considering whether or not the existing statutory requirement should be relaxed to allow LegCo Members to use the personal data in the electoral register. This is particularly important since existing electors have not given express consent to such use when registering as electors. For this reason, due regard should be given to the right to privacy of electors and any proposal of relaxation should require broad community consensus as a prerequisite.

CONCLUSION

- 33. Members are invited to note the key statistics of the 2013 PR of electors in paragraphs 3 to 14 above.
- 34. As regards the use of the electoral register, the Administration does not propose to introduce any legislative amendments to relax the use of electoral register and email addresses of electors for non-election related purposes, given the considerations set out in paragraphs 22 to 30 above.

Press Release Issued on 14 June 2013 – Provisional Registers of Electors and Omissions Lists Released Today for Public Inspection

The provisional registers of electors and omissions lists were released today (June 14) for public inspection until June 29.

About 3.47 million registered electors are contained in the 2013 provisional register for geographical constituencies, after taking into account about 56 000 who are newly registered and putting the names of about 53 000 electors who have passed away or have not reported their latest residential addresses in response to the inquiry letters of the Registration and Electoral Office (REO) onto the omissions list. The total figure represents a net increase of more than 3 000 electors when compared to last year.

The number of registered electors for functional constituencies (other than the District Council (second) functional constituency) in the provisional register is about 238 000, after taking into account about 1 000 newly registered electors, putting about 2 300 electors onto the omissions list, and taking into account some 1 400 electors who have changed to register under the District Council (second) functional constituency.

For the District Council (second) functional constituency, about 3.22 million registered electors are listed in the provisional register, after taking into account about 51 000 newly registered electors and some 1 400 electors who have changed to register under the District Council (second) functional constituency from the other functional constituencies, and putting another 50 000 onto the omissions list.

"In addition to the applications for new registration, the REO has received applications for updating registration particulars from about 100 000 registered electors. The respective provisional registers include all validated applications for registration as electors and applications for changes of particulars received. For those who are no longer eligible for registration, their names have been removed from the respective registers and recorded on the omissions lists," an REO spokesman said.

"The statutory deadline for updating registration particulars falls on June 29 this year. We appeal to the registered electors who have changed residential address to fulfil their civic responsibility by notifying the REO by the deadline so that the REO can update their records accordingly."

Anyone who has applied to be registered as an elector but does not find his name in the relevant register, or whose name is on the omissions lists or who finds his particulars incorrectly recorded, may also lodge a claim in person with the REO.

If anyone considers that a registered person is not eligible to be registered, he may lodge an objection in person with the REO.

"The deadline for lodging a claim or objection is June 29. The Revising Officer will consider the evidence provided by the applicant to rule in accordance with the legislation," the spokesman said.

Specified forms for claims and objections can be obtained from the REO (10/F, Harbour Centre, 25 Harbour Road, Wan Chai, or 10/F, Guardian House, 32 Oi Kwan Road, Wan Chai) and all District Offices. They can also be downloaded from the REO website (www.reo.gov.hk/en/voter/application.htm).

For the geographical constituencies and the District Council (second) functional constituency, full copies of the provisional register can be inspected during business hours (i.e. Monday to Friday, from 9am to 12.30pm and from 1.30pm to 6pm) at the REO on 10/F, Harbour Centre, 25 Harbour Road, Wan Chai. The relevant section of the register pertinent to a particular district is available for public inspection at the respective District Office during their business hours from Monday to Friday. As regards the omissions list for the geographical constituencies and the District Council (second) functional constituency, full copies are available for public inspection at the REO's Harbour Centre office and District Offices.

For functional constituencies (other than the District Council (second) functional constituency) and Election Committee subsectors, full copies of the provisional registers and omissions lists are available during business hours (i.e. Monday to Friday, from 9am to 12.30pm and from 1.30pm to 6pm) for public inspection at the REO's Harbour Centre office and its office on 10/F, Guardian House, 32 Oi Kwan Road, Wan Chai. They can also be inspected at the District Offices in Central, Mong Kok, Kwun Tong, Sha Tin and Tsuen Wan during their business hours from Monday to Friday.

Members of the public may also call the REO hotline on 2891 1001 to check whether their names are listed in the provisional registers or the omissions lists.

Statistical information about the provisional registers is available on the voter registration website (www.voterregistration.gov.hk).

The REO will publish the final registers of electors on or before July 25.
