## Panel on Development Hon James TO's Letter on HKSAR's Work in Support of Reconstruction in the Sichuan Earthquake Stricken Areas

We refer to your email of 16 May 2013 informing us that the Chairman of the Panel on Development had requested the Administration to respond to Hon James TO Kun-sun's letter of 15 May 2013 on proposed inclusion of the captioned subject on the agenda of the Panel meeting.

In the afore-mentioned letter, Hon James TO raised concerns about HKSAR's reconstruction support work in the Wolong Nature Reserve (Wolong), in particular, the China Conservation and Research Centre for the Giant Panda (CCRC) project, which according to a recent media report, was behind schedule and might involve misuse of public funds and arrears of wages of workers. Although the Administration subsequently clarified that the allegations were unfounded and that

the case was actually a dispute between the main contractor and one of the subcontractors and the latter used wage withholding as a negotiation tactic, Hon James TO opined that the public had expressed grave concerns and such incident might undermine public confidence in the HKSAR's reconstruction efforts.

The media report referred to in Hon James TO's letter was released on 9 May 2013. As the allegations in the report were unfounded and misleading, the Administration issued a press release on the same day to clarify that there was no misuse of public funds, the delay in completion of the CCRC project was primarily due to frequent damages of Wolong's access road, Provincial Road 303, by flash floods and massive mudslides/landslides causing blockage in transportation. Furthermore, severe weather in winter also caused suspension of works for more than six months, the adverse environment and working conditions resulted in an unstable workforce affecting adversely the progress of the works. For details, please refer to the enclosed press release.

In end May, the Development Bureau conducted an audit on the Wolong reconstruction projects and held meetings with the concerned parties including the Sichuan authorities and the main contractor of the CCRC project. The investigation reaffirmed that the case did not involve misuse of public funds and that the dispute between the contractor and the subcontractor had been resolved. The Sichuan side also had not received any other similar complaints. The crux of the matter is contractors' obligations under the contract and it should be dealt with according to the relevant Mainland regulations and rules.

Despite the adversities, the reconstruction work in Wolong has begun to bear fruit with the joint efforts of the Sichuan and Hong Kong governments. By the end of May this year, 14 projects were completed. Community projects such as schools and hospitals came into use progressively, greatly enhancing the living environment and quality of life of the Wolong community. As regards conservation and research facilities, several projects have been completed; the CCRC and the Giant Panda Conservation and Disease Control Centre in Dujiangyan are also near completion. The remaining projects such as the hydro-power station are expected to be completed progressively towards the end of this year despite their complexity.


The HKSAR's reconstruction work in Sichuan are proceeding in a rigorous and effective manner according to regulations. Fund management is

based on the principles laid down in accordance with the "Co-operation Arrangement on the HKSAR's Support for Restoration and Reconstruction in the Sichuan Earthquake Stricken Areas" agreed by the Sichuan and Hong Kong governments, with separate dedicated accounts for each and every project. Funds will be released according to the actual progress of the project. The HKSAR's "independent professional consultants" will also check the use of funds when carrying out the technical audits. The Sichuan Provincial Department of Supervision and Audit Office monitor and audit the HKSAR's reconstruction projects in accordance with the regulations. Each reconstruction project when completed will undergo an audit to ensure that funds have been well spent. Over the past four years, the system has been working effectively, ensuring that funds have been spent for their intended purposes.
