Action

I. Issues related to the provision of free kindergarten education

Members noted the background brief prepared by the Secretariat [LC Paper No. CB(4)486/12-13(02)] and the submissions from deputations/individuals not attending the meeting.

Briefing by the Administration

2. The Chairman said that as informed by the Secretary for Education ("SED"), he would join this special meeting at around 10:00 am due to prior official commitment. At the invitation of the Chairman, Permanent Secretary for Education ("PS(Ed)") briefed members on various issues relating to the

provision of free kindergarten education as set out in the Administration's paper [LC Paper No. CB(4)486/12-13(01)]. She advised that providing practicable 15-year free education and better quality kindergarten education was a priority of the current-term Government. The Administration had hitherto held over 20 meetings with stakeholders to better understand their needs and expectations on further enhancement to kindergarten education. She said that the Administration would also take note of the views of the deputations.

Oral presentation by deputations/individuals

3. A total of 38 and 33 deputations/individuals presented their views in the first session and the second session of the meeting respectively. Their major concerns were summarized in the **Appendix**.

Initial response by the Administration

4. SED thanked the deputations for their views. Regarding some deputations' query about the policy stance as stated in paragraph 3 of the Administration's paper [LC Paper No. CB(4)486/12-13(01)] that kindergarten education in Hong Kong was not part of basic education, SED explained that the Administration was actually referring to "compulsory education" when using the expression "basic education". Currently, kindergarten education was not part of compulsory education.

5. Noting the deputations' call for early implementation of free kindergarten education, SED said that owing to the diversity of views among stakeholders and the intricacies of the issues involved, the Education Bureau ("EDB") would set up a committee on free kindergarten education ("the Committee") shortly to examine the various issues. It was expected that the Committee would complete its work and put up recommendations to EDB in two years' time.

Discussions

6. The Chairman drew members' attention to Rule 83A of the Rules of Procedure which provided that a Member shall not move any motion or amendment relating to a matter in which he had a pecuniary interest, whether direct or indirect, or speak on any such matter, except where he disclosed the nature of that interest. He reminded members to declare interests, if any, in the matter under discussion.

Policy on the implementation of free kindergarten education

7. Mr CHEUNG Kwok-che shared some deputations' criticism that the Administration had excluded kindergarten education from the provision of basic education. Noting SED's explanation earlier on, the Deputy Chairman was of the view that the Administration should suitably revise paragraph 3 of its paper so as to accurately document its policy stance on the provision of kindergarten education.

8. SED said that the expression "basic education", as used in the paper, referred to nine years of free and compulsory primary and junior secondary education. Deputy Secretary for Education (3) ("DS(Ed)3") supplemented that the expression "basic education" was commonly used in the Administration's official documents, including curriculum documents, to refer to compulsory education, which currently did not include kindergarten education.

9. Dr Fernando CHEUNG recalled that the Chief Executive had pledged in his Election Manifesto to provide free early childhood education. However, the 2013 Policy Address had merely announced the setting up of a committee to examine the feasibility of free kindergarten education. Dr CHEUNG was concerned that the Administration had employed delaying tactics by tasking the Committee to study the feasibility of free kindergarten education, instead of formulating the implementation details. The Deputy Chairman, Mr LEUNG Kwok-hung and Mr CHEUNG Kwok-che shared Dr CHEUNG's concerns.

10. In response, SED stressed that the provision of free kindergarten education was a top priority of the current-term Government. The Committee was expected to study and make specific proposals on how to practicably implement free kindergarten education. To properly reflect the work of the Committee as stated by SED, Mr CHEUNG Kwok-che considered that the name of the Committee should be changed along the lines of "Committee on 3-Year Free Kindergarten Education". SED said that the suggestion would be conveyed to the Committee for consideration.

11. In response to Dr Helena WONG's enquiry on the membership of the Committee, SED said that the majority of members of the Committee and its working groups would comprise representatives from different stakeholders of the kindergarten sector. DS(Ed)3 supplemented that while membership of the Committee would include representatives from the education sector and the kindergarten sector, it should be noted that views of stakeholders would also be canvassed through inviting them to participate in focus group discussion to be organized by the Committee and its working groups.

Action

12. The Deputy Chairman said that earlier this morning, the 爭取 15 年免費教育大聯盟 (hereinafter referred to as "the Alliance") had submitted signatures from 7 719 kindergarten teachers and over 48 000 parents to EDB urging for the early implementation of free kindergarten education. Dr Fernando CHEUNG noted the broad consensus of the kindergarten sector on the eight major requests of the Alliance, and queried the need for setting up the Committee which would only come up with its recommendations in about two years' time. Dr Helena WONG said that Members of the Democratic Party supported the Alliance's eight major requests, and urged the Administration to provide a timetable on implementing free kindergarten education. The Chairman said that the Administration should announce a timetable, and he looked forward to early implementation of free kindergarten education in Hong Kong.

13. Dr Kenneth CHAN said that Members of the Civic Party supported the early implementation of free kindergarten education. He was gravely concerned about the delay arising from the Committee's two-year study and the further time taken by the Administration to consider the Committee's recommendations. Dr CHAN informed the meeting that he was conducting a study and would write to all kindergartens shortly to invite them to take part in a questionnaire survey.

14. SED said that he had been tasked by the Chief Executive to set up the Committee as soon as possible so that it could commence work and put forward practicable proposals early, which was in line with public expectation. He further advised that after the Committee had been set up, it would form about five working groups each tasked to review specific issues such as the finance and operations of kindergartens, salary framework and qualifications of teachers, the objective of kindergarten education etc. While the Committee would take about two years to complete its tasks and made recommendations to the Government, during this period, it would maintain communication with the kindergarten sector to listen to their views, and explore short- and medium-term measures which could help the kindergartens meet the challenges they would be facing. The Administration would actively consider providing support accordingly.

15. Mr LEUNG Kwok-hung said that in implementing free kindergarten education, the Administration should have adequate planning and deploy additional resources to ensure effective implementation. Noting that the Panel would hold another special meeting on 26 March, Mr LEUNG was of the view that the Administration should provide more concrete proposals on which deputations could give their views. He also considered it necessary for the Administration to formulate a proper objective for kindergarten education.

Action

16. SED advised that to facilitate the review, the Administration had prepared information papers on major issues of concern for the Committee's deliberation. The objective of kindergarten education would be one of the issues to be studied by the Committee. SED pointed out that as the Committee would examine pertinent issues relating to the practicable implementation of free kindergarten education, it was inappropriate for the Administration to give views on the way forward at this stage as this might pre-empt the Committee's consideration.

Pre-primary Education Voucher Scheme

17. Dr Helena WONG considered the existing support provided to the kindergarten education sector inadequate. Ms Starry LEE questioned whether the Administration had earmarked sufficient financial provision to cater for the needs of the kindergarten sector. In this regard, SED advised that government expenditure on kindergarten education had been increased from \$1.3 billion before the launch of the Pre-primary Education Voucher Scheme ("PEVS") to about \$2.9 billion in the 2012-2013 financial year. The implementation of PEVS had provided a solid foundation and useful operational experience for the future implementation of free kindergarten education.

18. Noting the imminent difficulties faced by the kindergarten sector, Mr LEUNG Kwok-hung was of the view that instead of awaiting the recommendations of the Committee, the Administration should seek funding on a non-recurrent and one-off basis to provide immediate support and enhance kindergarten education. In reply, SED informed members that as a short-term measure to enhance teaching and learning effectiveness, the Administration would seek the approval of the Finance Committee to provide an additional one-off grant in an amount ranging from \$150,000 to \$250,000 to kindergartens under PEVS.

19. To enhance interim support to kindergartens, the Deputy Chairman urged the Administration to consider increasing the subsidy for whole-day kindergartens. Ms Starry LEE recalled that in the last Term, the Panel had received views from deputations urging for an increase in the value of the voucher under PEVS pending any decision on free kindergarten education. Ms LEE was concerned that the Administration should deploy resources to implement interim measures to address the pressing needs of the kindergarten sector.

20. SED recapitulated that the Committee and its working groups would review and study a number of key issues including the mode of funding for kindergartens, salary scale and professional development for kindergarten

teachers etc. In addition to making recommendations on the way forward, the Committee would also explore and propose to the Administration any short-term measures that could be taken to address the pressing needs of the kindergarten sector.

Professional development of kindergarten teachers

21. Dr Kenneth CHAN was pleased to note that according to the information provided by the Administration in response to a written question raised by him at the Council meeting of 6 February 2013, in the 2012-2013 school year, over 3 000 and 6 000 kindergarten teachers possessed a Bachelor degree or Certificate in Early Childhood Education respectively. However, Dr CHAN said that he was not in favour of the Administration's plan to set up the proposed \$480 million scholarship scheme to subsidize some 20 outstanding local students to pursue degree courses or teacher training programmes in prestigious universities outside Hong Kong. He took the view that support should be provided to serving kindergarten teachers to address their professional training needs. In this connection, SED advised that the subsidy for professional training provided for serving kindergarten teachers would be extended for two more years to 2014.

22. Dr Helena WONG considered it necessary to improve the teacher-to-student ratio and when calculating the staffing establishment of kindergartens, school principals and administrative staff should not be counted towards the number of teaching staff. SED advised that the teacher-to-student ratio and staff establishment were among the issues to be reviewed and studied by a working group under the Committee.

23. Mr LEUNG Kwok-hung highlighted the importance of teacher training to tie in with the implementation of free kindergarten education. He also considered that the Administration should deploy additional resources for enhancing teacher training. The Chairman shared Mr LEUNG's concern, and pointed out that it was necessary to put in place a proper salary scale for kindergarten teachers so as to give due recognition to their qualifications and experience.

24. SED said that the Administration attached great importance to teacher training. About 90% of kindergarten teachers were in possession of the relevant certificate qualification while some other 1 000 teachers were pursuing relevant study. He also recapitulated the Administration's proposal to disburse the additional one-off grant to kindergartens under PEVS to help enhance the quality of kindergarten education.

Action

II. Any other business

25. The Chairman reminded members that the Panel had scheduled another special meeting at 9:00 am, Tuesday, 26 March 2013 to receive deputations' views. To facilitate deliberation at the next meeting, the Chairman and the Deputy Chairman considered that where practicable, the Administration should provide its response to the views and concerns raised by deputations and members at this meeting.

26. There being no other business, the meeting ended at 1:43 pm.

Issues related to the provision of free kindergarten education

Summary of views and concerns expressed by deputations/individuals

No.	Name of Deputation/individual	Major views and concerns
1.	Hong Kong Baptist University Early Childhood Education Society [LC Paper No. CB(4)486/12-13(03)]	The deputation was disappointed that the 2013 Policy Address had merely announced the establishment of a committee to examine the feasibility of free kindergarten education. It considered that the committee should draw up a roadmap to implement 15-year free education within two years. The deputation supported the eight major requests of 爭取 15 年免費教育大聯盟 ("the Alliance"). Its other requests included the provision of financial assistance for whole-day kindergarten schooling, lowering the teacher-to-student ratio and providing an in-service training allowance for serving kindergarten teachers.
2.	Hong Kong Sheng Kung Hui Welfare Council [LC Paper No. CB(4)486/12-13(04)]	The deputation was pleased with the Government's effort in enhancing early childhood education. It supported the implementation of 15-year free education, and urged for introduction of measures such as the provision of an adequate level of subsidy for whole-day kindergarten schooling, as well as improving the establishment of teaching staff.
3.	Professional Association of Master of Education in Early Childhood Education of Hong Kong Institute of Education [LC Paper No. CB(4)486/12-13(05)]	The deputation put forth eight major requests, which included the abolition of the Pre-primary Education Voucher Scheme ("PEVS") and introduction of fully subsidized early childhood education, provision of appropriate subsidy for whole-day kindergartens, lowering the teacher-to-student ratio, formulating a professional development pathway and salary framework for kindergarten teachers.

No.	Name of Deputation/individual	Major views and concerns
4	Hong Kong Early Childhood Education Administrative Professional Association [LC Paper No. CB(4)498/12-13(01)]	The deputation supported the eight major requests of the Alliance. It was concerned about the heavy workload of kindergarten teachers who were also required to take up administrative work. The deputation urged for lowering the ratio of teacher to students and the establishment of a salary and professional development framework for kindergarten teachers. It also considered that research on local early childhood education and the development of teaching and learning materials should both be strengthened.
5.	The Salvation Army [LC Paper No. CB(4)498/12-13(02)]	The deputation supported the implementation of 15-year free education, making reference to the findings in the "Report on Review of Pre-primary Education Voucher Scheme". It agreed that the teacher-to-student ratio and professional development for teachers should be improved. The deputation considered that where appropriate, improvement measures should be launched prior to completion of the study by the relevant committee in two years' time. It also highlighted the need to develop effective quality assessment tools to monitor the performance of kindergartens.
6.	Hong Kong Baptist Kindergarten Education Convention	The deputation urged for the early implementation of 15-year free education, and considered that the committee must draw up a roadmap for the implementation of 15-year free education within two years.
7.	Hong Kong Society for the Protection of Children [LC Paper No. CB(4)486/12-13(06)]	The deputation expressed disappointment that the 2013 Policy Address had merely mentioned the establishment of a committee to examine the feasibility of free kindergarten education. It supported the eight major requests of the Alliance, including the provision of full subsidy for kindergarten education at non-profit-making kindergartens and improving the subsidy mechanism for whole-day kindergartens, lowering the teacher-to-student ratio and introducing a salary structure for kindergarten teachers.

8.	Yaumatei Yang Memorial Methodist Pre-School [LC Paper No. CB(4)498/12-13(03)]	The deputation supported the eight major requests of the Alliance, and stressed the need to ensure fairness in education. In lieu of PEVS, the Administration should implement without delay free kindergarten education. The deputation's other main recommendations included reviewing the remuneration of kindergarten teachers and establishing a professional development framework for them. It also considered that qualified teaching personnel should be provided to cater for students with special educational needs ("SEN students").
9.	Miss Emily CHAN Han-ying	A salary structure for kindergarten teachers should be established and the Education Bureau ("EDB") should play an active steering role in taking forward 15-year free education within a reasonable timeframe.
10.	Allway Kindergarten	The deputation supported fully subsidized kindergarten education, and submitted that rising rent and teachers' salary had imposed tremendous financial pressure on the operation of kindergarten in recent years.
11	爭取 15 年免費教育大聯盟 [LC Paper No. CB(4)486/12-13(07)]	According to the deputation, it comprised 29 educational bodies and submitted eight major requests based on the consensus of the educational sector. These included full subsidy for children attending non-profit making kindergartens, improving the subsidy mechanism for whole-day kindergartens, strengthening the staffing establishment of teaching professional and supporting administrative staff, setting up a salary framework for kindergarten teachers and providing an in-service training subsidy for serving teachers, putting in place a quality assurance mechanism with an emphasis on self-assessment, abolishing the current arrangement of posting the reports of external assessment on-line. The deputation stressed that the membership of the committee to be set up by the Administration should comprise representatives from all stakeholders. The deputation

		suggested that a subcommittee should be set up under the Panel on Education to follow up the implementation of free kindergarten education.
12.	The Trustees of the Kowloon Tong Church of the Chinese Christian and Missionary Alliance	The deputation supported 15 years' free education and urged for its early implementation.
13.	Ms WONG Siu-kwan [LC Paper No. CB(4)486/12-13(08)]	She noted that the "Reform Proposals for the Education System in Hong Kong" published in 2000 had confirmed the importance of early childhood education as the foundation for life-long learning and all-round development. It urged the Government to establish within two years a mechanism for providing full subsidy for attendance at non-profit-making whole-day kindergartens; and in the interim, implement appropriate relief measures to assist these kindergartens. Given that kindergarten teachers were in possession of requisite qualifications similar to their counterparts in primary and secondary schools, the deputation was of the view that a proper salary scale should be provided for kindergarten teachers.</p>

She observed that while whole-day kindergartens provided a necessary service to working parents, PEVS provided a uniform level of subsidy for attendance at kindergartens without due regard to the special needs of whole-day kindergartens. She said that full subsidy should be provided for attendance at whole-day kindergartens. To enhance the quality of education, the existing teacher-to-student ratio should be lowered.</p>

It expressed concern about the heavy workload of kindergarten teachers, in particular the additional administrative duties required to be performed. The deputation was of the view that the implementation of 15-year free education could be taken as a form of recognition for the contribution of the kindergarten educators.</p>

It reiterated its view that education at non-profit-making kindergartens should be fully subsidized. In addition, the deputation considered it necessary to enhance the staffing establishment and facilities of kindergartens.
