

## SFC's response to the Hon Kenneth Leung's enquiries

We refer to the letter dated 7 January 2013 from the Clerk to the Legislative Council Panel on Financial Affairs (the Panel) to the Secretary for Financial Services and the Treasury, under which it is noted that the Panel members would like to discuss policy issues concerning the regulation of and licensing regime for corporate finance advisers and the enforcement actions taken by the Securities and Futures Commission (the SFC) against unlicensed parties, at the Panel meeting to be held on 4 February 2013. Please find below our response to these issues.

Regulation of and licensing regime for corporate finance advisers

Under the Securities and Futures Ordinance (the SFO), the SFC is empowered to license corporations and individuals. From a licensing perspective, the key factors that would trigger a licensing obligation are whether a person is carrying on a business in a *regulated activity* (as defined in Parts 1 and 2 of Schedule 5 of the SFO) or holding himself out as carrying on such business in a regulated activity, and if so, whether such business is carried on in Hong Kong.

Under the SFO, any corporation which carries on in Hong Kong a business in giving advice in respect of, among other things, an application for the listing on the SEHK of any securities, compliance with the Listing Rules, matters falling within the ambit of the Codes on Takeovers and Mergers and Share Repurchases, or any offer to dispose of securities to or acquire securities from the public, or advising listed corporations concerning corporate restructuring in respect of securities, is required to hold a licence for Type 6 regulated activity (advising on corporate finance). This is subject to limited exemptions, for example, the corporate finance advice is given by a corporation solely to its wholly owned subsidiary or its holding company which holds all its issued shares.

Enforcement actions taken against unlicensed parties

Under section 114 of the SFO, it is an offence for a person to carry on business in a regulated activity or for a person to hold himself out as carrying such a business unless the person is licensed by the SFC or authorised as a financial institution under section 119 or permitted to provide automated trading services under section 95.

The SFC maintains a program for detecting and taking action against unlicensed activity. In the last 3 years, the SFC has initiated over 90 investigations into suspected unlicensed activity leading to 19 criminal prosecutions in which 16 persons have been convicted and 2 have been acquitted. Another case is currently on foot and pending a hearing. All prosecutions have been the subject of media releases issued by the SFC on their completion. These cases include cases both where the person was charged with carrying on regulated activities without a license and cases where the allegation focussed on whether the person had held out he was carrying on such a business. A table of these prosecutions is attached.
