# Electronic Submission of Applications Relating to Food Business/Trade Licences and Permits

# **Purpose**

Starting from January 2013, the Food and Environmental Hygiene Department (FEHD) will accept online filing of applications for food business/trade licences and permits through the internet. This paper briefs Members on FEHD's plans.

# **Background**

2. At present, FEHD has promulgated 39 forms relating to food business/trade licences and permits. Of them, eight 1 may be filed electronically through e-mail and nine through online submission 2. For the remaining application forms related to food business/trade licences and permits, there are 12 categories of forms where the applicants are required to submit the filled-in paper form together with the proposed layout plans of the premises (if required 3) to FEHD. FEHD now plans to accept electronic submission of these forms as a facilitation measure for the trade. As regards the remaining 10 forms, since the applicants have to lodge original certificates in parallel, submission online is not feasible. The **Annex** gives further details about these forms, broken down by categories.

For these 12 categories of forms, submission of proposed layout plans is not required where the application is for restricted food permits, undertaker's licence, temporary food factory licence, transfer of places of public entertainment licence, and permission for live broadcast at cinema.

#### **New Service**

# Scope of New Service

3. The new arrangement for electronic submission of applications will cover 12 categories of forms involving the following 21 types of food business/trade licences and permits, of which the Director of Food and Environmental Hygiene is the licensing authority:

## Food Business Licences/Permits

- (a) General Restaurant Licence;
- (b) Light Refreshment Restaurant Licence;
- (c) Marine Restaurant Licence;
- (d) Factory Canteen Licence;
- (e) Food Factory Licence;
- (f) Bakery Licence;
- (g) Fresh Provision Shop Licence;
- (h) Siu Mei and Lo Mei Shop Licence;
- (i) Cold Store Licence;
- (j) Composite Food Shop Licence;
- (k) Frozen Confection Factory Licence; and
- (1) Milk Factory Licence; and
- (m) Restricted Food Permits.

#### Trade Licences/Permit

- (a) Swimming Pool Licence;
- (b) Commercial Bathhouse Licence;
- (c) Offensive Trade Licence;
- (d) Slaughterhouse Licence;
- (e) Funeral Parlour Licence;
- (f) Undertaker's Licence:
- (g) Places of Public Entertainment Licence<sup>4</sup>; and
- (h) Karaoke Establishment Permit.

#### **Operational Procedures**

4. Under the new arrangement, applicants seeking any of the licences and permits mentioned above may fill in the relevant electronic application form and submit it to FEHD together with the proposed layout plan(s), where required, in electronic format. The submitted layout plans

should meet the following criteria:

- (a) they should be in "PDF" format;
- (b) the total file size should not exceed 10 MB;
- (c) they should be drawn to the metric scale of not less than 1:100; and
- (d) the paper size of each plan should not be larger than A3.

Criteria (a) and (b) are technically simple to meet and commonly adopted for electronic files of the plans concerned. Criteria (c) and (d) reflect the formats commonly adopted by the trade for most of the applications.

5. On receipt of an application, FEHD will refer, through electronic means, its details together with the electronic plan(s) to the relevant government departments (such as the Fire Services Department, the Buildings Department, the Planning Department, etc.) for comments and consideration. Concerned departments will also reply to FEHD through electronic means.

# **Expected Benefits**

6. The new arrangement will provide the trade with the choice of submitting the licence/permit application through electronic means, on top of the submission of an application in paper form. Electronic submissions relieve traders from having to pay visits to FEHD Licensing Offices or District Environmental Hygiene Offices in lodging applications. Also, electronic submissions may help speed up the workflow and ease the dialogue among government departments as well as communication with the applicant.

#### Trade Consultation

7. We have consulted the trade on the introduction of the new arrangement to accept electronic submission of licence/permit applications. They are supportive of the arrangement and have indicated no difficulties in complying with the requirements set out in paragraph 4 above.

# **Next Steps**

8. We plan to roll out the new arrangement in January 2013. We will closely monitor its implementation and users' feedback, review its effectiveness in the light of operational experience, and introduce further improvements where necessary.

# **Advice Sought**

9. Members are invited to note and comment on our plan to accept online submission of applications for food business and trade licences set out in their paper.
