

LEGISLATIVE COUNCIL BRIEF

PUBLIC HEALTH AND MUNICIPAL SERVICES DESIGNATION OF PUBLIC LIBRARY

INTRODUCTION

The Director of Leisure and Cultural Services, in her capacity as the Authority (“Authority”) under the Public Health and Municipal Services Ordinance Cap.132 (“the Ordinance”), manages and controls the libraries listed in the Schedule to the Designation of Libraries Order (Cap.132 sub. leg. O). Under Section 105K of the Ordinance, the Authority may, by order published in the Gazette, designate any building, or part of a building, as a library.

2. We propose to amend the Schedule to the Designation of Libraries Order (Cap. 132 sub. leg. O) as follows:

By repealing everything after “Offices,” in item 50 -

“50. The part of the 5th floor of the Sai Kung Government Offices, Sai Kung (G.L.A. DS9), hatched red on the sketch plan dated 10 December 1984, signed by the Director of Urban Services and deposited in the Sai Kung District Office of the Leisure and Cultural Services Department.”

and substituting -

“The part of the 5th floor of the Sai Kung Government Offices, 34 Chan Man Street, Sai Kung, shown in pink on the floor plan numbered SKM8395, signed by the Director of Leisure and Cultural Services on 26 June 2013 and deposited in the Hong Kong Central Library.”

JUSTIFICATIONS

3. The Sai Kung Public Library is located at 5/F, Sai Kung Government Offices, 34 Ching Man Street, Sai Kung. To meet its operational needs, the library has recently been expanded by incorporating the adjoining area after

removal of the Sai Kung District Leisure Services Office of this Department. The amendment to the Schedule to the Designation of Libraries Order as proposed above shall come into operation on 15 November 2013. The proposal to designate the new premises as a library will enable the Authority to enforce the relevant regulations on its expansion to the adjacent premises for proper management.

AMENDMENT OF SCHEDULE TO THE DESIGNATION OF LIBRARIES ORDER (Cap. 132 sub. leg. O)

4. The Order at Annex A amends the Schedule to the Designation of Libraries Order to update the list of public libraries.

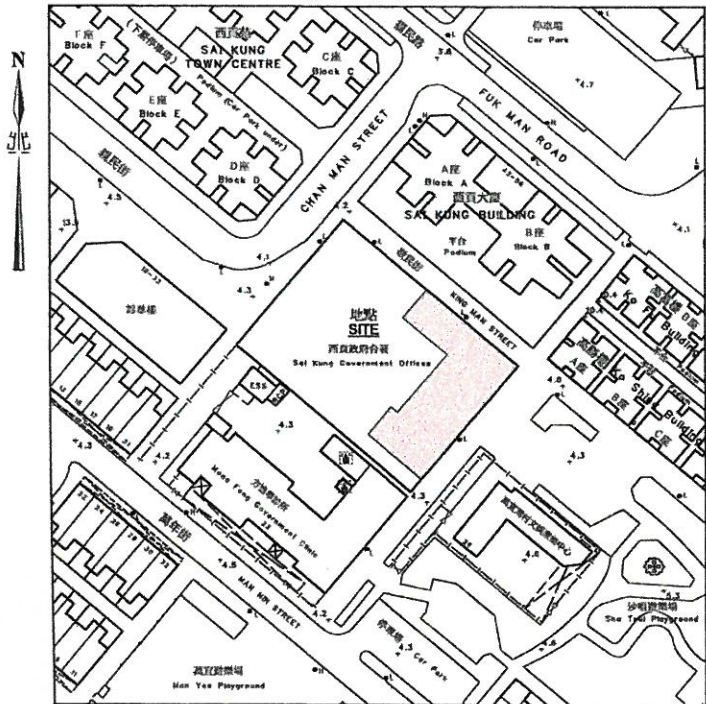

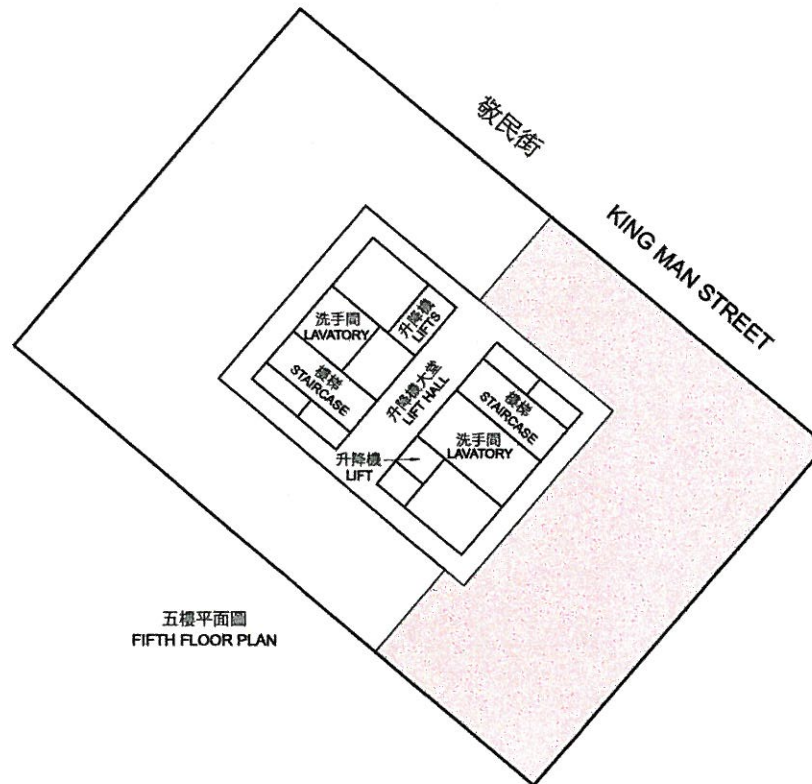
Explanatory Note

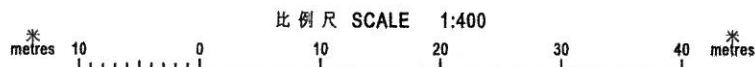
五樓平面圖
