Public Health and Municipal Services Ordinance (Cemeteries) (Amendment of Fifth Schedule) Order 2012

### INTRODUCTION

Annex

At the meeting of the Executive Council on 30 October 2012, the Council ADVISED and the Chief Executive ORDERED that the Public Health and Municipal Services Ordinance (Cemeteries) (Amendment of Fifth Schedule) Order 2012 (the Amendment Order) (Annex) should be made to delete the New Kowloon Cemetery No. 2 (Little Sisters of the Poor Cemetery) from Part II of the Fifth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) (PHMSO) (the Fifth Schedule) and delete the Garden of Remembrance (GoR) at Cape Collinson from Part I of the same Schedule.

## **JUSTIFICATIONS**

- According to section 118(1) of the PHMSO, any person who, without the permission in writing of the Authority, buries any human remains, or deposits any urn or other receptacle containing any human remains, or scatters the ashes of any human remains after cremation, otherwise than in a cemetery, shall be guilty of an offence. The Fifth Schedule specifies places as "cemeteries" for the purpose of the Ordinance by listing out public and private cemeteries in Hong Kong.
- (A) Closure of the New Kowloon Cemetery No. 2
- 3. The New Kowloon Cemetery No. 2 (Little Sisters of the Poor Cemetery) was first designated as a private cemetery in Part II of the Fifth Schedule in 1928. In 2003, the operator of the cemetery handed over the site for the redevelopment of the St. Joseph's Home for the Aged. In February

2006, the Town Planning Board (TPB) approved the redevelopment proposal and the approval was further renewed in February 2010. The cemetery site now forms part of a lot in a land exchange proposal currently under negotiation between the lot owner and Lands Department.

- 4. The cemetery operator has confirmed that all human remains previously buried in the cemetery in question had already been relocated either to the Cheung Sha Wan Catholic Cemetery or to the Chai Wan Catholic Cemetery. The site is no longer used as a cemetery and should therefore be deleted from the Fifth Schedule.
- (B) The GoR at Cape Collinson: Duplicated Listing in Parts I and VII of the Fifth Schedule
- 5. The GoR at Cape Collinson was built in 1962, before the enactment of the Cremation and Gardens of Remembrance Regulation (Cap. 132 sub. leg. M) (CGRR) in 1974. Hence, this GoR was included in Part I of the Fifth Schedule initially as a public cemetery. With the enactment of the CGRR in 1974, it would have been proper to (i) include the GoR at Cape Collinson under Part VII of the Fifth Schedule; and (ii) correspondingly delete the same GoR from Part I. The latter consequential amendment was however overlooked then. Except Cape Collinson, all the seven other GoRs were built after the enactment of CGRR.
- 6. The inclusion of the GoR at Cape Collinson in both Part I "Public Cemeteries" and Part VII "Gardens of Remembrance" of the Fifth Schedule is confusing. GoRs and public cemeteries are at present subject to provisions in two different pieces of subsidiary legislation, namely, the CGRR and the Public Cemeteries Regulation (Cap. 132 sub. leg. BI). We propose to remove the duplication by deleting the GoR at Cape Collinson from Part I of the Fifth Schedule.

#### OTHER OPTIONS

7. Short of amending the Fifth Schedule, there is no other alternative for delivering the updating and tidying-up exercise described in this brief.

### THE AMENDMENT ORDER

8. The Amendment Order seeks to delete -

- (a) the New Kowloon Cemetery No. 2 (Little Sisters of the Poor Cemetery) at Clear Water Bay Road from Part II of the Fifth Schedule; and
- (b) the GoR at Cape Collinson from Part I of the Fifth Schedule.
- 9. Under section 113(3) of the PHMSO, the Chief Executive in Council may by order amend, or add any cemetery to or delete any cemetery from, the Fifth Schedule.

### IMPLICATIONS OF THE PROPOSAL

11. The proposal has no economic, financial or civil service implications. The proposal will facilitate land exchange at a future date. The proposal is in conformity with the Basic Law, including the provisions concerning human rights. It has no productivity, environmental or sustainability implications.

# **PUBLIC CONSULTATION**

12. In February 2006, the TPB approved the redevelopment proposal pertaining to the site hitherto occupied by the New Kowloon Cemetery No. 2. The approval was further renewed in February 2010.
