LEGISLATIVE COUNCIL BRIEF PUBLIC HEALTH AND MUNICIPAL SERVICES SETTING ASIDE PREMISES FOR USE AS A CIVIC CENTRE

INTRODUCTION

The Director of Leisure and Cultural Services, in her capacity as the Authority ("Authority") under the Public Health and Municipal Services Ordinance Cap.132 ("the Ordinance"), manages and controls the civic centres listed in the Thirteenth Schedule to the Ordinance. Under Section 105M of the Ordinance, the Authority may, by order published in the Gazette, set aside any premises and the grounds appurtenant thereto for use as a civic centre.

2. We propose to amend the Thirteenth Schedule to the Ordinance by adding, after the item relating to Sheung Wan Civic Centre,

"The site and buildings known as the Oil Street Art Space at 12 Oil Street, North Point".

JUSTIFICATIONS

3. The proposal to set aside the new premises for use as a civic centre will enable the Authority to enforce the regulations relating to this civic centre for proper management. The designation of the Oil Street Art Space as a civic centre is in line with the arrangement for the Hong Kong Visual Arts Centre under the Authority's management, which is also a venue for arts-related exhibition and activities. The civic centre will be open for public use with effect from **20 May 2013**.

AMENDMENT OF THIRTEENTH SCHEDULE

4. The Amendment Order at Annex A amends the Thirteenth Schedule to the Public Health and Municipal Services Ordinance (Cap.132) to set aside the new premises for use as a civic centre.
