# **Explanatory Note**

The Road Traffic (Traffic Control) (Designation of Prohibited and Restricted Zones) Notice (Cap. 374 sub. leg. U) sets out in its Schedules certain prohibited zones and restricted zones in the Hong Kong International Airport. Specifically speaking—

- (a) Schedule 1 sets out prohibited zones in which the driving of certain motor vehicles is prohibited; and
- (b) Part 1 of Schedule 2 sets out restricted zones in which drivers of certain motor vehicles are prohibited from picking up or setting down passengers, and from loading or unloading goods.
- 2. This Notice amends that Schedule 1 to—
  - (a) designate certain areas as prohibited zones (section 3(2) and (5));
  - (b) vary the designation in respect of certain areas (section 3(1), (4), (6) and (7)); and
  - (c) remove an area from the list of prohibited zones (section 3(3)).
- 3. This Notice also amends Part 1 of that Schedule 2 to—
  - (a) designate certain areas as restricted zones (section 4(7) and (8));
  - (b) vary the designation in respect of certain areas (section 4(1), (5) and (9));
  - (c) amend the designation in respect of certain areas to remove certain road sections (which have been resumed by the Government for the works of Hong Kong—Zhuhai—Macao Bridge—Hong Kong Link Road, and separately designated as restricted zones by notice published in the Gazette on 20 July 2012 as G.N. 4936 of 2012) from being restricted zones (section 4(2), (3), (4) and (10)); and
