In this Schedule—

### **Explanatory Note**

Among the fees that, under section 9(2) of the Provision of Municipal Services (Reorganization) Ordinance (Cap. 552), continue to be in force as if they were made under section 6A of the Dutiable Commodities Ordinance (Cap. 109), certain fees in respect of liquor licences differ between the urban areas and the New Territories. The object of this Regulation is to align the fees concerned.

2. More specifically, this Regulation is to provide for the fees payable for—
  - (a) the issue or renewal of a liquor licence;
  - (b) the transfer of the licence;
  - (c) any amendment to the licence; and
  - (d) the issue of a duplicate of the licence.
