To

Amend the Kowloon Tong Church of the Chinese Christian and Missionary Alliance Incorporation Ordinance to enable the body corporate incorporated under that Ordinance to borrow or raise moneys.

Enacted by the Legislative Council.

1. Short title

This Ordinance may be cited as the Kowloon Tong Church of the Chinese Christian and Missionary Alliance Incorporation (Amendment) Ordinance 2014.

2. Kowloon Tong Church of the Chinese Christian and Missionary Alliance Incorporation Ordinance amended

The Kowloon Tong Church of the Chinese Christian and Missionary Alliance Incorporation Ordinance (Cap. 1031) is amended as set out in section 3.

3. Section 3 amended (powers of corporation)

After section 3(2)—

Nothing in this Ordinance shall affect or be deemed to affect the rights of the Central Authorities or the Government of the Hong Kong Special Administrative Region under the Basic Law and other laws, or the rights of any body politic or corporate or of any other person except such as are mentioned in this Ordinance and those claiming by, from or under them.
