
(2) 当工程進行期間,機管局以先斬後奏技倆向立法局各位議員攤大手板拿 1100 亿,你敢不敢不撥款?

I urge you to impose strong targeted economic sanctions on Hong Kong in response to their proposal to construct the 3rd runway which will kill Longheaded eagle ray, pale edged sting ray, goatee croaker, long tooth grouper, orange spotted grouper tooth grouper, Gorgonian, tiger toothed croaker (the endangered species on the red list), which is in breach of Amendments to Appendices I and II of CITES Adopted by the 16th Meeting of the Conference of the Parties. The indo-pacific humpacks dolphins (also known as pink dolphins) are in substance endangered species.

The proposed runway undermines the effectiveness of CITES which aim at protecting endangered species.

Diplomatic sanctions have not been sufficient to stop HK Government from proceeding with the 3rd runway or the construction of Nth runway in future.

In order to change barbarian behaviour of HK people, tough economic and/or trade sanctions must be imposed, targeting HK companies directly tied to the proposed runway.

Thousands of people overseas oppose killing endangered species and indo-pacific humpack dolphins. Please urge the HK government to promise to "strengthen the international moratorium on protection of the endangered species"
