Ms KWONG Chung-ching of Mouse Frontline said that the proposed copyright exceptions under the Bill would not provide adequate protection for users of copyright works who were engaged in online dissemination of UGC such as video clips of cover versions of songs or songs with rewritten lyrics, fan-made videos and streaming of video game playing. She said that UGC would not adversely affect the original work and should warrant exception. Mr Ricky FUNG of IFPI (HKG) Ltd said that UGC fell in the grey area between infringement and non-infringement of copyright and should be carefully studied before introduction of any wide copyright exception for it. 		Producers & Distributors Association of Hong Kong Limited said that ownership of the copyright of a work would become unclear if copyright created for UGC. Mr Anthony LEE of Federation of Hong Kong Filmmakers cautioned that UGC exception should be assessed on a case by case basis rather than benefitting from a blanket approval. Mr Kenny WONG Kam-shan of the Law Society of Hong Kong said that the Society considered that the concept of UGC might be considered in light of overseas developments but such consideration should be left to the next round of updating exercised and it should not delay the current legislative work on updating the copyright regime which was long overdue.	
		Mr Martin LIAO said that all exceptions should be based on the respect and protection of copyright. A balance should be struck between protection of copyright and freedom of expression.

		They considered that the scope of permitted acts should include a wide range of common activities engaged by users on the Internet which might make use of copyright works on social media websites such as YouTube, Facebook and discussion forums, e.g. altered pictures/videos, mashups, doujinshi, image/video capture, streaming of video game playing, homemade videos and rewritten lyrics of songs.			
		Mr Charles Peter MOK was of the view that the introduction of exception for UGC would provide greater, if not absolute, protection for users of copyright works.			
		The Administration advised that the proposed fair dealing exceptions and the high threshold for criminal liability would provide adequate protection for users of copyright works by exempting their civil and criminal liabilities under appropriate circumstances. It was unlikely that UGC which did not amount to a substitute for the original copyright work would be caught by the criminal net. Given the legal principles governing civil liability, frivolous or vexatious civil claims would not be entertained by the court. The Administration believed that there should be reasonable safeguards to minimize abuse of civil litigation.			
		Discussion on the need to balance the interest of copyright owners and the right of users of copyright works, and the need to update the copyright regime of Hong Kong.			
		The Administration conssidered that the Bill represented a balance between copyright protection and reasonable use of copyright works, and would continue to work wit LegCo and stakeholders with a view to passing the Bill to update the copyright regime as soon as possible.
