- 2. The Bills Committee requested the Administration to
 - (a) provide a list of documents required for an application for a specified instrument (i.e. a licence, an exemption or a temporary suspension of liability) and advise the estimated time required for an applicant to provide the relevant documents;
 - (b) advise the time allowed for private columbarium operators to apply for specified instruments;
 - (c) provide information on the enforcement actions the relevant government departments would take under their purview against non-complaint columbaria, as provided for under the relevant legislation;
 - (d) provide information on the land-related, planning-related and building-related requirements a private columbarium operator must meet in order to obtain a licence;
 - (e) provide information on policies on land premium for columbarium premises;

- (f) provide a formula for calculating land premium equitably for niches that had been sold;
- (g) consider deleting the term "關於" from clause 22(2)(a)(i);
- (h) review the drafting of clause 22(2) and 22(9)(a); and
- (i) consider revising the wording of clause 22(8).
