#### I. Meeting with the Administration

[File Ref.: FH CR 2/3751/07, LC Paper Nos. CB(3)740/13-14, CB(2)2141/13-14(01), CB(2)2338/13-14(08), CB(2)431/14-15(01), CB(2)630/14-15(01), CB(2)367/15-16(01) to (04), CB(2)486/15-16(01)(Further revised) to (02)(Revised), CB(2)548/15-16(01)(Revised) to (02)(Revised), CB(2)548/15-16(03) to (05) and CB(2)721/15-16(01)(Revised) to (02)]

<u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).

(At 5:48 pm, the Chairman suspended the meeting to allow members of the Bills Committee who were also members of the Panel on Development ("the Panel") to proceed to the meeting venue of the Panel for voting on a motion. The meeting resumed at 5:53 pm).

## 2. The Bills Committee requested the Administration to:

- (a) if it decided to put forward Committee stage amendments ("CSAs") to fine-tune the timing required for on-site claim period and impose a fine for contravening section 7(1)(c) of Schedule 5, provide such amendments to the Bills Committee for consideration;
- (b) consider notifying landlords when applications for licences for operating columbaria were received in respect of their premises;

- (c) consider moving CSAs to fine-tune the arrangements for applications for occupation orders and appeals on decisions made by the court and applications for court orders (including the appeal mechanism) mentioned in section 9(6) and (8) of Schedule 5;
- (d) consider moving CSAs to section 10 of Schedule 5;
- (e) consider informing mortgagees of the licence applications in respect of the columbarium premises under mortgage;
- (f) provide a written response to spell out the information to be required under section 11(1)(b) of Schedule 5 in the Bill or under subsidiary legislation;
- (g) consider whether a person who failed to take the steps to facilitate the return of ashes under section 12 of Schedule 5 would be subject to lighter sanction;
- (h) provide a written response in relation to the scenario under which the Director of Food and Environmental Hygiene ("DFEH") knew that there were pending legal proceedings and how DFEH might dispose of the ashes which were in his/her possession;
- (i) consider reviewing section 16 of Schedule 5;
- (j) provide a written response explaining why it was considered appropriate for the specified person (in this case the Board of Management of the Chinese Permanent Cemeteries) to remain subject to regulation under the Public Health and Municipal Services Ordinance (Cap. 132) and the Private Cemeteries Regulation (Cap. 132 sub. leg. BF), rather than under the Bill;
- (k) consider spelling out the particulars of columbaria to be set out in the list under the new section 113A(5) of Cap. 132 added by clause 112;
- (l) consider moving CSAs to amend the definition of "columbarium" in the Bill; and
- (m) consider uploading the register of private columbaria on the Internet for access by the public.

### II. Any other business

- 3. <u>The Chairman</u> said that the Bills Committee should continue to discuss the Administration's responses to the issues raised by members at previous meetings (LC Paper No. CB(2)721/15-16(02)) and commence the discussion of the final version of CSAs at the next meeting to be held tentatively in end-March 2016. <u>Members</u> agreed.
