Opening Remarks

by the Secretary for Home Affairs in Moving a Motion to Amend

the Resolution of the Board of Directors of the Po Leung Kuk under the Interpretation and General Clauses Ordinance on 16 April 2014

President,

I move the motion, as printed on the agenda, to amend the Resolution of the Board of Directors of the Po Leung Kuk (PLK).

- 2. The Resolution seeks to amend the Schedule to the Po Leung Kuk Ordinance to enable PLK to establish, maintain and manage medical and health care institutions in Hong Kong and to provide all kinds of medical and health services for the Hong Kong community. The proposal has the policy support of the Administration.
- 3. The Resolution was laid on the table of the Legislative Council on 26 February 2014 and scrutinised by the Subcommittee subsequently. While the Subcommittee supported the Resolution, it has put forward some views on individual provisions. In the light of members' views, we have proposed certain amendments to enhance clarity of the provisions of the Resolution.
- 4. First of all, in view that PLK has undertaken to provide medical and health services free of charge or at low charges, some members have suggested providing expressly PLK's fee charging policy in the Resolution. Hence, one of the amendments that I propose is to stipulate in the Schedule to the Ordinance that the object of PLK shall be to provide all kinds of medical and health services, free of charge or at low charges, for the Hong Kong community.
- 5. In addition, I propose to make some technical amendments to enhance clarity of the provisions concerned. For example, elaborating that PLK may establish, maintain and manage medical and health care institutions including clinics, dispensaries, health centres and hospitals, etc. in Hong Kong.

- 6. The amendments that I move have incorporated the views of the Subcommittee. I would like to take this opportunity to express my gratitude to the Hon MA Fung-kwok, the Chairman of the Subcommittee, and other members of the Subcommittee for their invaluable comments.
- 7. I appeal to Members to support the passage of the motion. Thank you, President.
