

ITEM FOR FINANCE COMMITTEE

LOTTERIES FUND HEAD 341 – NON-RECURRENT GRANTS

Members are invited to approve an allocation of \$65,043,000 from the Lotteries Fund for meeting the construction costs of a new Contract Residential Care Home for the Elderly with a Day Care Unit for the Elderly at the ancillary facilities block in the public rental housing development of the Housing Authority at the site of Anderson Road, Kwun Tong.

PROBLEM

There is a need to provide more subsidised residential and day care places for the elderly to meet the substantial and growing demand.

PROPOSAL

2. The Director of Social Welfare, with the support of the Secretary for Labour and Welfare and the Lotteries Fund Advisory Committee (LFAC), proposes to allocate \$65,043,000 from the Lotteries Fund (LF) to meet the construction costs of a new Contract Residential Care Home for the Elderly (RCHE) with a Day Care Unit for the Elderly (DCU) at the ancillary facilities block in the public rental housing (PRH) development of the Housing Authority (HA) at the site of Anderson Road, Kwun Tong (the subject site).

JUSTIFICATION

3. The Social Welfare Department (SWD) proposes to construct a 100-place Contract RCHE together with a DCU with 20 subsidised places at the subject site. Out of the 100 places in the Contract RCHE, 60 are subsidised

residential care places, including 54 nursing home (NH) places and six care and attention (C&A) places upon admission; and 40 are non-subsidised residential care places. The subject site has been identified for PRH development to provide about 17 500 domestic flats for accommodating a planned population of 48 300. Its location plan is at Enclosure 1. The proposed Contract RCHE with DCU will have a net operational floor area of about 1 179 square metres. One shared-use lay-by and one exclusive-use parking space^{Note} will be provided for the proposed welfare facilities. The Housing Department (HD), as the executive arm of HA and the works agent of the subject PRH development, will be entrusted with the design and construction of a set of bare-shell premises for the proposed Contract RCHE with DCU at the purpose-built ancillary facilities block in the subject PRH development according to the specifications of SWD. Such entrustment arrangement would enable the proposed welfare facilities to be provided as an integral part of the PRH development in a timely manner. It would also facilitate better planning and an optimal use of the subject site.

4. Upon completion of the construction works, SWD will take over the facilities and select a suitable operator through invitation of tenders for the operation, management and maintenance of the proposed Contract RCHE with DCU. Taking into account the construction lead time required for the entire development, it is estimated that the contract of the proposed Contract RCHE with DCU will be awarded in 2018. The facilities to be provided in the proposed Contract RCHE with DCU upon fitting out are detailed at Enclosure 2.

FINANCIAL IMPLICATIONS

Capital cost estimates

5. The funding sought under this submission (\$65,043,000) relates to the estimated construction cost of the proposed Contract RCHE with DCU. It is worked out on the basis of the construction floor area and technical requirements of the proposed welfare facilities as assessed by HD. A breakdown of the cost estimate is as follows –

^{Note} One shared-use lay-by and one exclusive parking space for the Contract RCHE with DCU will be constructed for the proposed welfare facilities. Parking space is standard provision for RCHE with DCU to facilitate the transport and escort of frail elderly persons.

HA will be reimbursed the actual cost of construction by phases according to the works schedule.

6. The funding for the fitting-out works of the proposed Contract RCHE (including the non-subsidised section) with DCU, as well as the procurement of furniture and equipment for the subsidised section of the proposed Contract RCHE with DCU, will be separately sought under LF in accordance with the established mechanism when the construction is near completion.

Recurrent financial implications

7. The estimated recurrent funding requirements for the operation of the proposed Contract RCHE (subsidised section) with DCU in a full year, including personal emoluments, other charges, rates and government rent and after netting off income from service users' fees, is \$14,958,000. The recurrent funding estimate is derived with reference to the standard notional staffing of the relevant welfare facilities at present. The necessary recurrent provision will be included in the draft Estimates of the relevant years.

PUBLIC CONSULTATION

8. A community engagement workshop on the PRH development was conducted by HD on 29 November 2008, with participants from representatives of nearby public housing residents, schools, non-governmental organisations (NGOs) and Members of the Legislative Council (LegCo) and the Kwun Tong District Council (KTDC). HD further consulted KTDC on several occasions from January 2009 to January 2010. The proposed PRH development, including the proposed Contract RCHE with DCU, was supported in all these consultation sessions. We consulted the LegCo Panel on Welfare Services on 9 June 2014. The Panel supported the proposal.

BACKGROUND

9. It is the Government's policy to promote "ageing in place as the core, institutional care as back-up". In line with this policy, SWD strives to increase the supply of both subsidised residential care and community care services.

Encl. 3 10. The provision of subsidised residential care places and the number of elderly persons on the waiting list, as at end-April 2014, are set out at Enclosure 3. SWD has been making strenuous efforts to increase the provision through various measures. Development of new Contract RCHEs is a major initiative in this regard.

11. Since 2001, SWD has awarded contracts through open tenders to NGOs or private operators to operate 24 purpose-built RCHEs. Among these 24 Contract RCHEs, 22 Contract RCHEs were in operation, providing a total of 1 676 subsidised places (about 87% are NH places and 13% are C&A places upon admission) and 1 197 non-subsidised places as at end-April 2014. The remaining two are under renovation.

12. Day care services for frail elderly persons are provided in DCUs and Day Care Centres for the Elderly (DEs). The services provided by DCUs and DEs are largely the same, except that the former is usually attached to an RCHE while the latter is usually a stand-alone service unit. As at end-April 2014, there were 67 DEs and DCUs, providing a total of 2 752 subsidised day care places.

13. On top of the existing places set out in paragraphs 11 and 12 above, from 2014-15 to 2016-17, seven Contract RCHEs/Contract RCHEs with DCUs will commence service to provide a total of 532 new subsidised residential care places (of which 90% are NH places and 10% are C&A places upon admission) and 281

Encl. 4 non-subsidised places. As for subsidised day care places, a total of 102 new places
Encl. 5 will be provided in DCUs attached to Contract RCHEs while another 167 new places have been/will be provided through three DEs during the same period (including one DE which commenced service in early June). Details are at Enclosure 4. In addition, SWD has earmarked sites in 11 development projects, as set out at Enclosure 5, for the construction of new Contract RCHEs, Contract RCHEs with DCUs and DEs. One of these sites is the subject site.

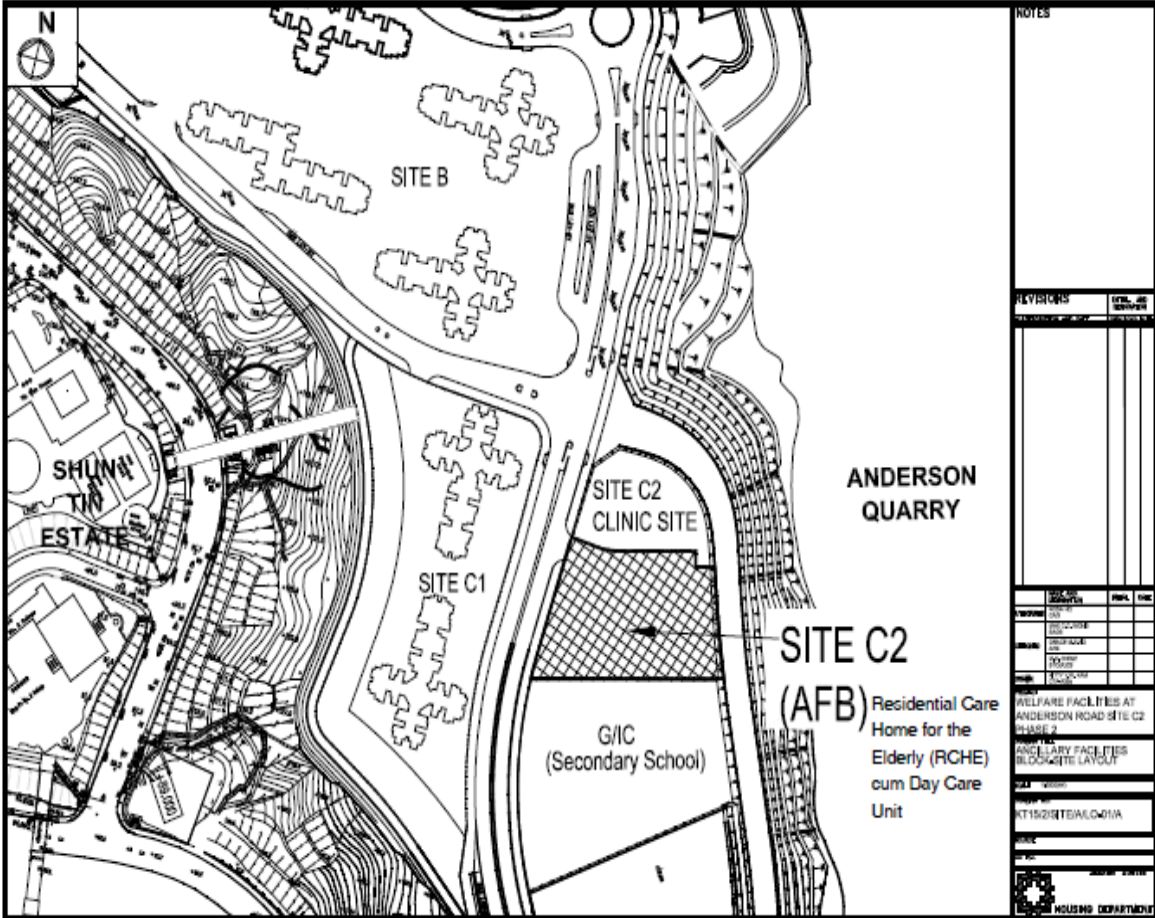
14. The costs of construction, fitting-out works and procurement of furniture and equipment of social welfare facilities are funded by LF. Under section 6(4) of the Government Lotteries Ordinance (Cap. 334), the Financial Secretary has the authority to approve payments from LF to finance the development of social welfare services. In line with the established practice, the approval of FC is sought for this proposal, as the recurrent cost is estimated to exceed \$10 million per annum (see paragraph 7 above).

Encl. 6 15. At its meeting on 21 May 2014, LFAC endorsed the proposed LF allocation of \$65,043,000 for the construction of the proposed Contract RCHE with DCU at the subject site. The membership and terms of reference of LFAC is at Enclosure 6.
