It is stated in part (4) of the reply no. LWB(WW)0065 that the new system being developed is solely for handling applications and cases of the social security schemes administered by the Social Welfare Department ("SWD"). Earlier on, Mrs Carrie LAM CHENG Yuet-ngor, Chief Secretary for Administration, mentioned that a one-stop service would be launched in future for processing various applications for welfare benefits currently under the purview of different departments, such as the Old Age Living Allowance and the rent allowance for public housing tenants. When will such service be available? Does the Administration have any action plan or timetable? Noting that it takes the SWD as long as 6 or 7 years to replace a system, and with repeated delays, it may take an even longer time to develop a system for the provision of such one-stop service. Will the Administration expedite its action in this respect?

Following the Efficiency Unit's study on the opportunities for systemic improvement in benefits administration, the Chief Executive announced in the 2014 Policy Address that the Government would commission an external consultancy study to examine the feasibility of providing a more user-friendly one-stop service for benefits administration. The study is expected to be completed within 2014. Details of implementation, including plans and time-tables, will be further deliberated upon conclusion of the consultancy study.

1. GRS plans to procure copies of 227 archival records relating to Hong Kong from the National Archives of the United Kingdom (TNA) in 2014-2015. They are selected from nine records series of TNA. Apart from records relating to the future of Hong Kong (such as Sino-British negotiations and transfer of sovereignty), these records also cover other subjects like immigration control policy, New Territories development, political intelligence, defence of Hong Kong, political relations between Hong Kong and China, constitutional development, Kowloon Walled City, Vietnamese refugees, British nationality law, immigration from China to Hong Kong, naturalization in Hong Kong etc. Details of these records are as follows:
