Action

I. Confirmation of the minutes of the 25th meeting held on 23 May 2014

The minutes were confirmed.

II. **Matters arising**

Report by the Chairman on his meeting with the Chief Secretary for Administration

2. The Chairman said that there was nothing special to report.

III. Business arising from previous Council meetings

Legal Service Division report on bill referred to the House Committee in accordance with Rule 54(4)

Kowloon Tong Church of the Chinese Christian and Missionary Alliance Incorporation (Amendment) Bill 2014 (LC Paper No. LS57/13-14)

3. The Chairman said that this was a Member's Bill introduced by Dr Priscilla LEUNG. As the Bill had yet to receive its first and second reading at the Council meeting of 28 May 2014, the House Committee ("HC") would decide on the need to form a Bills Committee after the Bill had been read the first and second times and was referred to HC in accordance with the Rules of Procedure. Members noted the arrangement.

IV. Business for the Council meeting of 11 June 2014

- 4. <u>The Chairman</u> said that 22 questions (six oral and 16 written) had been scheduled for the meeting.

7. <u>The Chairman</u> said that pursuant to the arrangement agreed at the last HC meeting, the above two Members' motions originally scheduled for the Council meeting of 7 May 2014 would be dealt with at the Council meeting of 11 June 2014.

V. Position on Bills Committees and subcommittees

(LC Paper No. CB(2)1626/13-14)

8. <u>The Chairman</u> said that as at 29 May 2014, there were 16 Bills Committees, six subcommittees under HC and nine subcommittees on policy issues under Panels in action. Two subcommittees on policy issues were on the waiting list.

VI. Proposed parliamentary visit to Northern Europe organized by the Parliamentary Liaison Subcommittee

(LC Paper No. CB(4)531/13-14)

- 9. At the invitation of the Chairman, <u>Ms Emily LAU</u>, Chairman of the Parliamentary Liaison Subcommittee ("the Subcommittee"), briefed Members on the following proposals of the Subcommittee -
 - (a) to organize a visit by a Legislative Council ("LegCo") delegation to Finland, Norway and Denmark in Northern Europe in mid-September 2014, tentatively from 14 to 21 September 2014;
 - (b) to increase the number of fully-sponsored Members on a parliamentary visit organized by the Subcommittee in the current term from eight to nine, taking into account the increase of the number of Members from 60 to 70 in the Fifth LegCo; and to maintain the number of self-financing Members participating in any visit at seven; and
 - (c) to adopt the proposed mechanism, which was modelled on the one used for past visits, for selecting Members to join visits organized by the Subcommittee in the current term.

- 10. Regarding the proposed visit to Northern Europe in mid-September 2014, Ms Emily LAU said that the Subcommittee considered it worthwhile to organize a visit to the three Northern European countries to gain first-hand information on the operation of their unicameral legislatures and grand coalition governments formed by parliamentary alliances. The LegCo Secretariat was liaising with the relevant consulates on the visit arrangements. Subject to HC's endorsement of the Subcommittee's proposals, applications from Members to join the visit would be invited.
- 11. Mr Albert CHAN said that each Member was provided with an overseas duty visit ("ODV") account of \$55,000 in one term for the purpose of duty visits outside Hong Kong organized by committees of the Council. He sought clarification whether parliamentary visits organized by the Subcommittee were funded separately. In his view, for the sake of fairness, there should not be separate funding arrangements for parliamentary visits organized by the Subcommittee, which should be subject to the same funding cap applicable to overseas duty visits organized by other committees of the Council.
- 12. Referring Members to paragraph 8 of the paper, Ms Emily LAU said that according to the established arrangements approved by The Legislative Council Commission ("the Commission"), the financial provision for visits to other legislatures organized by the Subcommittee was separate from the ODV accounts provided to individual Members in each term for overseas duty visits organized by other committees of the Council. The approved budget for parliamentary visits organized by the Subcommittee for the 2012-2016 LegCo term was \$2 million. She added that Members had been consulted on the proposed mechanism for selecting Members to join visits organized by the Subcommittee. The outcome of the consultation had also been reported to Members.
- 13. In response to Mr Albert CHAN, the Chairman said that should Members have any views on the financial arrangements for parliamentary visits organized by the Subcommittee, they could convey their views to the Commission.
- 14. At the invitation of the Chairman, <u>Assistant Secretary General 4</u> explained the proposed mechanism for deciding how the nine fully-sponsored places and seven self-financing places for such delegations should be allocated in the current term.
- 15. <u>The Chairman</u> put to vote the Subcommittee's proposals regarding overseas parliamentary visits organized by the Subcommittee. <u>Mr Albert CHAN</u> requested a division.

The Chairman further said that a recommendation would be made to the Commission that the number of fully-sponsored Members on a parliamentary visit in the current term be set at nine.
