#### Paper for the House Committee Meeting on 21 February 2014

**Proposals of the Committee on Members' Interests** to amend the Registration Form on Members' Interests

#### **Purpose**

This paper invites the House Committee to consider the proposals of the Committee on Members' Interests ("CMI") to amend the Registration Form on Members' Interests ("Registration Form") in accordance with the results of the recent consultation with all Members on the proposed changes to the requirements for registration of Members' interests.

#### **Background**

- 2. At its meeting held on 24 October 2013, CMI considered the changes proposed by CMI of the Fourth Legislative Council to the registration requirements to enhance transparency and accountability. These include:
  - (a) the nature of work to which the remuneration relates should be provided under the categories of "directorships", "remunerated employment, offices, etc." and "clients";
  - (b) the estimated amount/value of the sponsorship received by Members or their spouses arising out of the membership of the Council should be provided under "overseas visits";
  - (c) more details on the location and usage of the land or property owned by Members (except for self-occupation) should be provided under the category "land and property";

- (d) the dates of changes to the registrable interests under the categories of "directorships", "remunerated employment, offices, etc.", "clients", "shareholdings" and "land and property" should be provided;
- (e) a new category of registrable interests i.e. "remunerated membership of boards, committees or other organizations" should be added:
- (f) the Registration Form should be made a part of the Rules of Procedure ("RoP"); and
- (g) the layout of the Registration Form should be changed and points to note should be set out in the form of "Important Notes" at the beginning of the Form.
- 3. At the same meeting, CMI also examined in particular the existing registration requirements for sponsored overseas visits and proposed the following changes:
  - (a) advancing the time for registration of sponsored overseas visits from "within 14 days of the conclusion of the visit" to "before departure for the visit"; and
  - (b) requiring Members to provide more particulars of sponsored overseas visits: (i) the reasons for their participation and, if applicable, their spouses' participation in the visit, and (ii) the itinerary of the visit.
- 4. CMI decided that all Members be consulted by way of a questionnaire on the proposed amendments to the registration requirements as set out in paragraphs 2 and 3 above.

#### **Outcome of consultation**

5. The questionnaire was issued to all Members on 11 November 2013. Except for the President, all the other 69 Members responded. A summary and details of Members' responses are set out in **Appendices I and II** respectively.

- 6. According to the consultation outcome, a majority of the responding Members agreed to the following proposed amendments to the registration requirements:
  - (a) Members should be required to register the following additional particulars
    - (i) the start dates of having and the dates of ceasing to have, during the term, registrable interests under the categories of "directorships", "remunerated employment, offices, etc." and "clients";
    - (ii) the dates of ceasing, during the term, to own/hold shares of each company which has been registered; and
    - (iii) the reasons for participation in sponsored overseas visits; and
  - (b) the layout of the Registration Form should be revised.

#### **Proposals of CMI**

- 7. Having considered the outcome of the consultation, CMI decided at its meeting on 29 January 2014 to take forward the proposed amendments in paragraph 6 above and proposed to amend the Registration Form. The amended Registration Form is in **Appendix III**. The proposed amendments concern only the provision of additional particulars of registrable interests in and the layout of the Registration Form. They do not require the amendment of Rule 83(5) of the RoP.
- 8. As the Council passed on 8 January 2014 the resolution to amend Rule 83(5)(a) and (h) of the RoP with effect from the commencement of the new Companies Ordinance (Cap. 622) on 3 March 2014<sup>1</sup>, consequential amendments are required to be made to the relevant pages of the Registration Form. CMI therefore proposed that the amended Registration Form in Appendix III should take effect from 3 March 2014.
- 9. CMI also proposed that the requirements for Members to provide the additional particulars referred to in paragraph 6(a) above should have no retrospective effect.

- 2. It may be hard for a legislator to form an estimate of the value of a trip, especially before departure.
- 3. In reality, the requirement for Members to estimate the sponsored amounts/values of overseas visits undertaken is difficult to implement, and it is difficult to make the estimation method standardized and consistent. This proposal may create counter-effects and undermine the credibility of the Register. (*Translation*)
- 4. Members will have difficulties in declaring the estimated value of a sponsorship. Underestimation will arouse public queries. It is proposed that when making a declaration, Members should be required only to state the facts, including the arrangements for accommodation, transport, meals, etc. in respect of the hospitality received. It should be left to the public to judge the estimated value.(*Translation*)
- 5. The estimated value may not be accurate. It is proposed that Members should be required only to declare the flight class and the names of the hotels where they stay. (*Translation*)
- 6. Sometimes it is quite difficult to estimate the value. It is proposed that only the relevant arrangements be provided. (*Translation*)

#### **Important Notes**

#### Time limits for registration of interests

Every Member is required to not later than the first meeting of each term furnish to the Clerk to the Legislative Council ("LegCo") in the Registration Form on Members' Interests ("the Registration Form") particulars of his registrable interests (Rule 83(1) of the Rules of Procedure ("RoP")).

2. Every Member is required to furnish to the Clerk to LegCo within 14 days of any change to his registrable interests (Rule 83(3) of RoP).

#### **Register of Members' interests**

- 3. Particulars of registrable interests are entered in a Register of Members' Interests ("the Register") for public inspection (Rule 83(4) of RoP).
- 4. The main purpose of the Register is to provide information of any pecuniary interest or other material benefit which a Member receives which might reasonably be thought by others to influence his actions, speeches or votes in the Council, or actions taken in his capacity as a Member of the Council. Members are required to have this general purpose in mind when determining what interests should properly be disclosed.
- 5. It is for individual Members to provide the required information and be responsible for what is recorded about himself in the Register, as each is answerable to his fellow Members and the public.
- 6. The registration of interests is additional to, and in no way a replacement of, the requirement on Members to disclose pecuniary interests under Rule 83A of RoP which is reproduced hereunder:

"In the Council or in any committee or subcommittee, a Member shall not move any motion or amendment relating to a matter in which he has a pecuniary interest, whether direct or indirect, or speak on any such matter, except where he discloses the nature of that interest."

- 7. As far as the RoP are concerned, it is not a breach to receive material benefits, provided that the material benefits are registered in accordance with Rule 83 of the RoP. Whether or not the acceptance of a particular material benefit is in contravention of the provisions of the Prevention of Bribery Ordinance (Cap. 201) or other Ordinances is a matter for the Member to decide for himself having regard to his own knowledge of the circumstances.
- 8. For details of the registrable interests which are required to be registered under Rule 83 of the RoP, please refer to the explanatory notes in each category of registrable interests in the Registration Form. Further guidance can be found in the Guidelines on Registration of Interests which is available from the LegCo Secretariat and the LegCo website.
- 9. If there is not enough space for completing any section of the Registration Form, additional sheets may be attached to it. Each sheet should carry the Member's signature.
