## Report No. 5/13-14 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

## Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire on 27 November 2013.

3. The House Committee formed two subcommittees to study item (1), as well as items (2) to (4) respectively in detail at its meeting on 11 October 2013. The former Subcommittee reported its deliberations to the House Committee on 15 November 2013 vide LC Paper No. CB(4)134/13-14. The latter Subcommittee made a verbal report at the House Committee meeting on 15 November 2013, and provided Members with a written report issued vide LC Paper No. CB(1)350/13-14 on 20 November 2013.

4. In respect of items (5) to (8), the House Committee considered it not necessary to form any subcommittee to study these items of subsidiary legislation.

Note: Regarding the Air Pollution Control (Air Pollutant Emission) (Controlled Vehicles) Regulation (L.N. 160/2013), the Council passed on 20 November 2013 a resolution moved by Hon Cyd HO, Chairman of the relevant Subcommittee, to extend the period for amending the Regulation to 18 December 2013.
