Action

I. Election of Chairman and Deputy Chairman

Mr LEE Cheuk-yan, the member with the highest precedence among those who were present at the meeting, presided over the election of the Chairman of the Subcommittee. He invited nominations for the chairmanship of the Subcommittee.

- 2. <u>Ir Dr LO Wai-kwok</u> nominated Mr Martin LIAO and the nomination was seconded by <u>Mr CHAN Kam-lam</u>, <u>Mr Frankie YICK</u> and <u>Mr Tony TSE</u>. <u>Mr Martin LIAO</u> accepted the nomination. There being no other nominations, <u>Mr LEE Cheuk-yan</u> declared that Mr Martin LIAO was elected Chairman of the Subcommittee. Mr LIAO then took over the chair.
- 3. <u>The Chairman</u> invited nominations for the deputy chairmanship. <u>Mr CHAN Kam-lam</u> nominated Mr Tony TSE and the nomination was seconded by <u>Mr Frankie YICK</u> and <u>Ir Dr LO Wai-kwok</u>. <u>Mr Tony TSE</u> accepted the nomination. <u>The Chairman</u> called for other nominations.
- 4. <u>Mr LEE Cheuk-yan</u> nominated Mr WU Chi-wai and the nomination was seconded by <u>Mr Charles Peter MOK</u>. <u>Mr WU Chi-wai</u> accepted the nomination.
- 5. As there was no other nomination, the Chairman announced that voting be conducted by secret ballot. After members present had cast their

votes, the Chairman invited Mr CHAN Kam-lam and Mr LEE Cheuk-yan, who had nominated the two candidates, to monitor the counting of votes. Of the members present, seven voted for Mr Tony TSE and five voted for Mr WU Chi-wai. The Chairman declared that Mr Tony TSE was elected Deputy Chairman of the Subcommittee.

II. Any other business

- 6. The Chairman said that the primary work of the Subcommittee was to study the terms of reference ("TOR") of the Select Committee; size of the Select Committee and procedure for the nomination of Members for appointment to the Select Committee. He would hold another meeting in late September or early October to discuss the above matters. He would liaise with the Secretariat and inform members about the details of the meeting accordingly.
- 7. Mr Gary FAN suggested that the scope of work of the Select Committee should reflect the content of the Petition presented by Mr WU Chi-wai and Mr Charles Peter MOK at the Council meeting of 25 June 2014 ("Petition") and cover matters proposed to be examined in the Petition.

- 8. <u>Mr WU Chi-wai</u> concurred with Mr FAN. He requested the Secretariat to send the proposed TOR having regard to the Petition for members' consideration before the next meeting.
- 9. <u>Mr Gary FAN</u> said that some of the members who were also members of the Panel on Transport would participate in the duty visit to Singapore from 23 to 26 September 2014. He requested that the date of the next meeting should avoid clashing with the period of the duty visit. <u>Members</u> agreed.
- 10. There being no other business, the meeting ended at 2:26 pm.
