An Ordinance to amend the Village Representative Election Ordinance and related legislation to provide for the office of kaifong representative for Cheung Chau and Peng Chau; to provide for Kaifong Representatives elections and extend certain functions of the Electoral Affairs Commission to those elections; to improve the voting and counting arrangements for Village Representatives elections; to limit election expenses for a Village Representative or Kaifong Representative election with over 5,000 electors; and to make related, consequential or minor textual amendments.

[4 April 2014]

Enacted by the Legislative Council.

**Part 1**

**Preliminary**

**1. Short title and commencement**

- (1) This Ordinance may be cited as the Rural Representative Election Legislation (Amendment) Ordinance 2014.
- (2) This Ordinance—

- (a) for all purposes relating to the elections of Resident Representatives, Indigenous Inhabitant Representatives and Kaifong Representatives in 2015—comes into operation on the day on which it is published in the Gazette; and
- (b) in so far as it has not come into operation under paragraph (a)—comes into operation on 1 April 2015.

**2. Enactments amended**

- (1) The enactments specified in Parts 2 to 6 are amended as set out in those Parts.
  - (2) The provisions set out in an item in column 1 of Schedules 1, 2, 3, 4 and 5 are amended by repealing the words and characters set out in column 2 of that item and substituting the words and characters set out in column 3 of that item.

## Part 2

### Amendments to Village Representative Election Ordinance (Cap. 576)

#### 3. Long title amended

- (1) The long title, after “Composite Indigenous Village;”—

**Add**

“to provide for the establishment of the office of kaifong representative for a Market Town;”.

#### 4. Section 2 amended (interpretation)

**Repeal the definitions.**

- (3) Section 2(1)—

**Add in alphabetical order**

“*Kaifong Representative* (街坊代表), in relation to a Market Town, means a holder of the office of kaifong representative established for the Market Town under section 6A(1);

*Market Town* (墟鎮) means a market town—

- (a) the name of which is specified in column 1 of Schedule 3A; and
- (b) the area of which is coloured pink and edged red on the map that bears the number specified in column 2 of Schedule 3A opposite that name;

*office of rural representative* (鄉郊代表職位)—

- (a) in relation to an Existing Village, means the office of resident representative established for the Village under section 5(1);
- (b) in relation to an Indigenous Village, means the office of indigenous inhabitant representative established for the Village under section 6(1);
- (c) in relation to a Composite Indigenous Village, means the office of indigenous inhabitant representative established for the Village under section 6(2);
- (d) in relation to a Market Town, means the office of kaifong representative established for the Market Town under section 6A(1);

***Rural Area*** (鄉郊地區) means an Existing Village, an Indigenous Village, a Composite Indigenous Village or a Market Town;

***rural by-election*** (鄉郊補選), in relation to a Rural Area, means an election to elect a person as a Rural Representative for the Rural Area, otherwise than at a rural ordinary election for the Rural Area;

***rural ordinary election*** (鄉郊一般選舉), in relation to a Rural Area, means—

- (a) the first election to elect a person as a Rural Representative for the Rural Area; or
- (b) if the office of rural representative for the Rural Area is vacated in accordance with section 7(2)(b) or (3)(b), an election to elect a person as a Rural Representative for the Rural Area to fill the vacancy;

***Rural Representative*** (鄉郊代表)—

- (a) in relation to a Village, means a Village Representative for the Village;
- (b) in relation to a Market Town, means a Kaifong Representative for the Market Town;”.

## 5. Section 3A added

After section 3—

**Add**

### “3A. Map of Market Town

- (1) The Director must—
  - (a) keep at the Director’s office each of the maps referred to in column 2 of Schedule 3A; and

- (b) during the ordinary business hours of that office, make at least one copy of each of those maps available for inspection by members of the public free of charge.
- (2) If a map is certified by the Director as a true copy of a map on which a Market Town is delineated, the map as so certified is conclusive evidence of the delineation of the Market Town for any purpose related to an election.”.

**6. Section 6A added**

After section 6—

**Add**

**“6A. Office of kaifong representative for Market Town**

- (1) There is established for a Market Town the office of kaifong representative with effect from the date specified in column 3 of Schedule 3A opposite the name of the Market Town specified in column 1 of that Schedule. The number of persons to hold the office of kaifong representative established for a Market Town is specified in column 4 of that Schedule opposite the name of the Market Town specified in column 1 of that Schedule.
- (2) A Kaifong Representative is to be elected under this Ordinance.
- (3) The function of a Kaifong Representative for a Market Town is to reflect views on the affairs of the Market Town on behalf of the residents of the Market Town. A Kaifong Representative is not to deal with any affair relating to the lawful traditional rights and interests of indigenous inhabitants.”.

**7. Section 9 amended (when a Village Representative is disqualified from holding office)**

After section 9(5)—

**Add**

“(6) A person elected as a Kaifong Representative for a Market Town is disqualified from holding office if, at any time after the election, the person ceases to be a resident of the Market Town.”.

**8. Section 15 amended (who is eligible to be registered as an elector)**

(1) After section 15(3)—

**Add**

“(3A) A person is not, because of being registered as an elector for a Market Town in the existing final register for the Market Town that is in effect, entitled to have the person’s name included as an elector for the Market Town in any subsequent provisional register for the Market Town if the Electoral Registration Officer is satisfied on reasonable grounds that the person has not been a resident of the Market Town for the 3 years immediately before the compilation of the provisional register. The Electoral Registration Officer may omit the person’s name from the final register for the Market Town.”.

(2) After section 15(5)—

**Add**

“(5A) A person is not eligible to be registered as an elector for a Market Town unless the person—

- (a) is a resident of the Market Town;
- (b) has been a resident of the Market Town for the 3 years immediately before the date of application for registration;

- (c) is an adult, or will be an adult on or before 20 October next following the person's application for registration; and
- (d) is a Hong Kong permanent resident.”.

(3) Section 15(6)—

**Repeal**

everything after “elector”

**Substitute**

“for—

- (a) 2 or more Existing Villages may be registered for only one of those Villages of that person's choice;
- (b) 2 Market Towns may be registered for only one of those Market Towns of that person's choice; or
- (c) one or more Existing Villages and one or more Market Towns may be registered for only one of those Existing Villages or one of those Market Towns of that person's choice.”.

**9. Section 22 amended (who is eligible to be nominated as a candidate)**

After section 22(2)—

**Add**

- “(2A) A person is eligible to be nominated as a candidate at an election for a Market Town only if the person—
- (a) is a resident of the Market Town;
  - (b) has been a resident of the Market Town for the 6 years immediately preceding the nomination;
  - (c) has reached 21 years of age;
  - (d) is registered, and eligible to be registered, as an elector for the Market Town;



- (e) is not disqualified from voting at the election; and
- (f) is not disqualified from being nominated as a candidate at the election, or from being elected as a Kaifong Representative for the Market Town, because of section 23 or any other law.”.

**10. Section 23 amended (when a person is disqualified from being nominated as a candidate and from being elected as a Village Representative)**

After section 23(4)—

**Add**

“(5) A person is disqualified from being elected as a Kaifong Representative for a Market Town if, at any time after the close of nominations of candidates for election for the Market Town, the person ceases to be a resident of the Market Town.”.

After section 25(6)—

**Add**

“(6A) To avoid doubt, if a person is—

- (a) an elector for a Market Town; and
- (b) an elector for an Indigenous Village or a Composite Indigenous Village,

and the person has in one of those capacities subscribed the specified number of nomination forms as regards an election for the Rural Area concerned, subsection (2) is not to be construed as preventing the person from subscribing other nomination forms in accordance with this section in another of those capacities.”.

**1. Interpretation**

In this Schedule—

*amending Ordinance* (《修訂條例》) means the Rural Representative Election Legislation (Amendment) Ordinance 2014 (5 of 2014);

*Market Town* (墟鎮) means—

- (a) the Market Town known as “Cheung Chau” which is included in Schedule 3A added by section 16 of the amending Ordinance;
- (b) the Market Town known as “Peng Chau” which is included in Schedule 3A added by section 16 of the amending Ordinance.

**2. The first election for a Market Town**

The first election to elect a person as a Kaifong Representative for a Market Town is to be held in 2015.

**3. Registration of electors for Market Towns**

Section 15(1)(a) does not apply in relation to the registration of a person as an elector for a Market Town in the first provisional register, or the first final register, to be compiled and published for that Market Town after the date on which the amending Ordinance is published in the Gazette.

**4. Compilation of first Market Towns provisional register**

Section 17(3), (4)(a) and (b), (5) and (6) does not apply in relation to the compilation of the first provisional register for Market Towns after the date on which the amending Ordinance is published in the Gazette.”

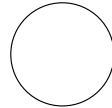

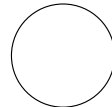

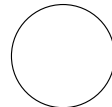
