Position Paper on Environmental Infrastructure Projects

Background

The Environmental Bureau submitted a paper ("CB(1)931/13/14(01)") seeking the Panel of Environmental Affairs's ("the Panel") support to:

- upgrade 5164DR (Southeast New Territories (SENT) landfill extension) to Category A;
- upgrade **5177DR** (Integrated Waste Management Facilities (IWMF) Phase 1) to Category A;

and reported progress on the following 2 projects previously supported by the Panel:

- **5163DR**: Northeast New Territories (NENT) landfill extension; and
- 5165DR: West New Territories (WENT) landfill extension.

CanCham's Position

CanCham believes that waste management is a pressing issue in Hong Kong and that the HKSAR Government ("the Government") must have a holistic plan to tackle the issue. CanCham welcomes the "Hong Kong Blueprint for Sustainable Use of Resources 2013-2022" published by the Environment Bureau (ENB) in May 2013, in which a specific reduction target on the disposal rate of Municipal Solid Waste (MSW) is set, supported by multi-dimensional measures.

CanCham supports the 3 landfill extension projects (5164DR, 5163DR, 5165DR) for the following reasons:

- It is recognized that despite the Government's waste reduction targets are achieved, there will still be about 10,000 tonnes of waste that requires disposal every day in 2017.
- The three planned landfill extensions will add around 100 million cubic metres of landfill capacity.
- The Government will implement a number of enhancement measures, including the establishment of the Restored Landfill Revitalization Funding Scheme, enhanced enforcement against fly-tipping and odour-control measures.
- If the Government fails to achieve approval to fund landfill extensions, Hong Kong will likely have no choice but to either export waste – an expensive proposition and raft with challenges in finding a jurisdiction that would accept the waste – or face the reality of a complete breakdown of the current waste management system in Hong Kong.

While CanCham supports the landfill extension projects, we urge the Government to implement stringent controls to minimise environmental impacts and to ensure all mitigation measures are delivered at the highest possible standard.

Cancham supports the Integrated Waste Management Facilities (5177DR) for the following reasons:

- CanCham recognizes Hong Kong's imminent need for integrated waste management facilities in the form of modern and well-proven incinerators, such that the volume of waste required to be landfilled can be minimized and the lifespan of the landfill sites can be extended as long as practicable.
- CanCham believes that incineration is needed as part of the overall waste solution and therefore CanCham supports the waste incineration initiative. We understand however there may still be different opinions about proceeding IWMF Phase 1 at the Shek Kwu Chau site or the Tsang Tsui site.



Therefore we suggest the Government to enhance its communication to the public on the merits of its proposed site as well as Hong Kong's longer term incineration requirement, including possible subsequent phases of the IWMF.

Waste management requires contribution from every part of society. The Government should take every effort to ensure a balance of contributions from each one. CanCham encourages Government to maintain an effective communication channel with the community and business sector to explain plans for Hong Kong's future waste management and to respond to public concerns.

A clean environment is essential to the sustainable development of Hong Kong. A clear and holistic waste reduction plan can enhance the city image and attract investment. CanCham supports the Government to step up efforts on waste management and is committed to work together with the society to achieve the waste reduction targets.
