## LEGISLATIVE COUNCIL PANEL ON ENVIRONMENTAL AFFAIRS

#### **Restored Landfill Revitalisation Funding Scheme**

## PURPOSE

This paper sets out details of the proposed Restored Landfill Revitalisation Funding Scheme (hereafter referred to as the Scheme), and seeks Members' support for making a submission to the Finance Committee for the non-recurrent funding of \$40 million to meet the starting costs and initial operating deficits of the projects under the Scheme.

#### BACKGROUND

2. As announced by the Chief Executive in the Policy Address 2014, the Government has earmarked \$1 billion to set up the Scheme to fund the development of recreational facilities or other innovative proposals at restored landfills so that the community can benefit from them at the earliest opportunity. The Scheme is proposed to be opened to applications from Non-Profit making Organisations (NPOs) or National Sports Associations (NSAs).

#### **OBJECTIVES OF THE SCHEME**

3. There are 13 closed landfills in Hong Kong which were restored between 1997 and 2006 to minimise their potential adverse impacts on the environment and to render them safe for beneficial use. The Government has started converting these restored landfills into recreational facilities such as recreational ground, sports facility, park, etc.. As of today, six restored landfills have already been fully developed for public use or reserved for conservation or other uses. This successful experience showcases that restored landfills can be turned into gainful and pleasant facilities for enjoyment by the general public. A summary of the 13 restored landfills is shown in <u>Annex 1</u>.

4. The Scheme is launched with a view to expediting the development of recreational facilities or other innovative applications at the restored landfill sites. Specifically, the objectives of the Scheme are to:

- (a) put restored landfills into good and innovative uses;
- (b) expedite the development of gainful afteruses at restored landfills so that the community can benefit from them at the earliest opportunity; and
- (c) promote active public participation in the development of suitable facilities at the restored landfills.

## Steering Committee on the Restored Landfill Revitalisation Funding Scheme

5. To take the Scheme forward, the Secretary for the Environment (SEN) has appointed a Steering Committee to advise him on the operational arrangements of the Scheme, merits of the applications received and the funding support to be granted, as well as to monitor progress of supported applications and other related matters on the Scheme. The Committee is chaired by a non official Chairman and comprises members from the fields of accounting, architecture/engineering, sports, social services as well as representatives of District Councils with restored landfills. Representatives of concerned Bureaux/Departments would also join the Committee as ex-officio members. The terms of reference and membership of the Steering Committee are at <u>Annex 2</u>.

6. A preparatory meeting of the Steering Committee was held on 9 May 2014 to discuss the operational arrangements of the Scheme. Members supported the Scheme and agreed on the proposed modus operandi of the Scheme as outlined in the following paragraphs.

## **Proposed Modus Operandi**

7. The proposed modus operandi of the Scheme is as follows:

#### (a) Eligibility of Applicants

- (i) NPOs<sup>[1]</sup> or NSAs<sup>[2]</sup> are eligible to apply.
- (ii) Application in personal capacity will not be accepted.

#### **(b)** Application Procedures

- (i) Invitation will be invited in batches. The Government will publish a list of restored landfills <sup>[3]</sup> (the published list) that are available for application in each batch under the Scheme.
- (ii) Resource kits in the form of Guide to Application and Site Information Sheets will be prepared for applicants. In addition, open days / site visits will be arranged to allow prospective applicants to view the restored landfill sites.
- (iii) Applicants will be required to submit a conceptual plan comprising initial design of a proposed development at the restored landfill of their choice, proposed use of the facility, schedule of implementation including works and future operation of the proposed development, rough cost estimates on the implementation plan including works and operation, and statements on its financial and management capability to undertake the project with proposed funding support if approved.
- (iv) Applicants are required to bear all the fees, if any, incurred by them in preparing their submissions in the application stage.

#### (c) Assessment of Applications

(i) The Steering Committee will assess and examine the applications received and recommend to the SEN on which

applications to be given approval in principle.

- (ii) Applications will be assessed based on the following criteria:
  - (a) Engineering and environmental feasibility of the project

This includes compatibility with landfill restoration at site, arrangement and measures to address the site constraints, environmentally friendly elements, compliance with relevant legislation, etc.;

(b) Project's benefits and acceptance by the community

This includes benefits to the community, enjoyment of the project by the public at large, social and recreational value, environmental benefits, compatibility with town planning and other committed uses in the vicinity, innovative and green architectural design or uses, support from District Council(s) etc.;

(c) Management capability of the applicant

This includes track record and past experience on similar projects, intended commitment, cross sector collaboration etc.; and

(d) Financial viability and sustainability of the project

This includes projected income and recurrent expenditure, demand of service(s), source of non-government funding and financial support required (if any) from Government for meeting the capital starting costs and operating deficits etc.

(iii) Applicants with approval in principle granted will be required to prepare detailed planning and engineering design of the project.

## (d) Scope of Funding

- (i) The following funding support will be provided to applicant(s) who receive approval in principle:-
  - (a) capital grant to cover the cost for the capital works and

related matters (including consultancy fees for pre-construction studies or works e.g. detailed planning, architectural, landscape and engineering design and site investigation incurred). The level of the grant for capital works and related matters will be considered on a case-by-case basis depending on factors such as the size and the proposed usage of the site, subject to a cap of \$100 million per project;

- (b) if justified, a time limited grant to meet the starting costs and operating deficits (if any) of the facilities for a maximum of the first two years of operation may be made as well. All proposals supported under the Scheme should be self-sustainable after this initial period. The financial ceiling for such grant is set at \$5 million <sup>[4]</sup> per project; and
- (c) the Government will charge only nominal rental for the restored landfill site through a land licence.
- (ii) Approved project should be of non-profit-making in nature. Successful applicant will be required to set up a dedicated account for each individual project. Any revenue earned from the project has to be ploughed back to the dedicated account for operation of the project and any surplus, if available, upon completion of the project or on expiry of the land licence, should be returned to the Government where applicable.
- (iii) We will ensure there would be no duplication of funding support for the capital works with other project(s) funded by the Government.

#### (e) Monitoring Mechanism

(i) Applicants in receipt of the funding support under the Scheme will be required to submit a master programme for the project,

with all milestone dates identified. In addition, the applicants are required to submit a quarterly progress report during the project preparation, construction and initial operation stages.

- (ii) A land licence will be granted by the Environmental Protection Department (EPD) to the successful applicant (now becomes "the licensee") to occupy the restored landfill site for a fixed period for the proposed use. EPD will closely monitor the licensee's operation to ensure their compliance with the terms and conditions set out in the land licence and approval conditions recommended by the Steering Committee. The successful applicant must also comply with procurement requirements stipulated by EPD and the Steering Committee, who may additionally impose suitable conditions in addition procurement procedures. the general Upon to commissioning of the developed facility, the licensee will be required to submit annual reports with audited accounts for monitoring purpose.
- (iii) Apart from reviewing the progress and regular reports submitted by the applicants, EPD and the Steering Committee, when necessary, may conduct on-site checking of selected projects with a view to enhancing monitoring of the approved projects.

8. To ensure proper governance of the Scheme, we will seek the advice of the Independent Commission Against Corruption (ICAC) on the assessment criteria and procedures to be adopted as well as other matters related to the operation of the Scheme as appropriate.

#### Secretariat of the Scheme

9. EPD will provide secretariat support to the Steering Committee and be responsible for administration of the Scheme including the processing of applications, issue of land licence to successful applicants, monitoring of project progress and exercising control on the expenditure including administering payments in accordance with pre-determined milestones, overseeing proper auditing and accounting work. 10. In addition, EPD will provide advisory service for successful applicants to take forward their proposal and to facilitate their submission and application under the Town Planning Ordinance (Cap. 131) and/or the Environmental Impact Assessment Ordinance (Cap. 499) as and when necessary. EPD will also assist successful applicants to consult the relevant District Council and stakeholders on their proposals and in liaising with the concerned departments as appropriate. However, the responsibility to make necessary statutory (or licensing if any) submissions still rests with the successful applicants.

## **Financial Implications and Arrangement**

#### Capital Works Expenditure

11. The afteruse of the restored landfill will have to be developed in accordance with the proposal approved under the Scheme. The Government will provide appropriate financial support for the implementation of the projects and has earmarked \$1 billion under the Capital Works Reserve Fund for this purpose. The development works will be carried out by the authorized agents to be engaged by the successful applicants. We will seek approval of capital works funding for individual project approved in principle by the Steering Committee by making submissions to the Public Works Subcommittee (PWSC) and the Finance Committee (FC) pursuant to the established arrangement.

#### Non-recurrent Expenditure

12. To facilitate the implementation of the Scheme (notably to meet the grant to be made available to selected NPOs or NSAs for supporting the initial operational costs of their proposals), subject to Members' support, we propose to seek approval of FC for a separate sum of \$40 million to meet with the starting costs and operating deficit for the first two years, subject to a cap of \$5 million per successful application under the Scheme.

#### **Revenue** implications

13. We propose to charge nominal rental for the restored landfill sites because the projects under the Scheme would be non-profit-making in nature and for the benefit of the community at large, which is in line with the existing rental arrangement under the Land (Miscellaneous Provisions) Regulations (Cap. 28A). The revenue implication will thus be insignificant.

## **Consultation with Stakeholders**

14. We have organised briefings and site visits for the relevant stakeholders to introduce the Scheme and seek their initial views since its announcement. More than 80 participants from around 40 NPOs, NSAs and other interested parties attended two briefing sessions on 23 January 2014 and 20 February 2014. In addition, site visits to restored landfills were held on 19, 21 and 24 March 2014 with 109 participants from around 40 organisations. Those who participated in the briefing sessions and site visits welcomed the setting up of the Scheme and strongly suggested the Government to include subsidy for meeting the starting costs and operating deficits in the initial years of operation, apart from the one-off grant to cover the capital works.

## **Implementation Schedule**

15. Subject to Members' views and approval of the FC, the Steering Committee aims to invite applications for the first batch of sites by the fourth quarter 2014. A tentative action timetable is set out as follows:

- (iii) Recommend the level of subsidy to the successful applicants both in terms of the one-off capital cost and the one-off grant to meet the initial operating deficits;
- (iv) Monitor progress and evaluate the effectiveness of approved projects under the Scheme;
- (v) In the case of non-compliance by the successful applicants under the Scheme, advise appropriate actions to be taken;
- (vi) Advise on other matters relating to the Scheme; and
- (vii) Engage stakeholders and foster community support to projects under the Scheme through public education and community involvement.
