**Legislative Council Panel on Education**  
**Issues Related to the Supply and Demand of Kindergarten Places**

**Purpose**

This paper sets out issues related to the supply and demand of kindergarten (KG) places and our response to the matters raised in the letter of Hon Michael TIEN Puk-sun referred by the Panel on Education.

**Supply and Demand of KG Places**

2. On the whole, there are sufficient KG places in various districts throughout Hong Kong to meet the demand of school-age children. With reference to the actual number of KG students in the 2012/13 school year and the number of cross-boundary students already attending KGs in Hong Kong and the year-on-year progression of these students, we currently have put the estimated demand for KG places in the 2014/15 school year at about 168 000, which can be fully met by the projected supply of about 241 000 places (including the number of places in vacant classrooms of KGs) across the territory.

3. It is worth noting that in projecting the overall demand of KG places in Hong Kong, we will take into account factors including:

- (a) the number of students (including cross-boundary students) already enrolled in KGs;
- (b) the projected school age population, which is compiled based on the population projections and the latest demographic changes (including the number of newly-arrived children from the Mainland) as updated by the Census and Statistics Department from time to time;
- (c) the KG attendance rates for children of different age groups and the latest trend; and
- (d) the estimated number of cross-boundary students.

Among the above factors, the population projections are based on a number of factors and assumptions. Of particular relevance is that related to babies born in Hong Kong to Mainland women. However, it is difficult to predict with accuracy the actual number of such babies who would settle in Hong Kong and if so, when. As for the number of cross-boundary students, it is subject to year-on-year changes depending on family factors, distribution of their places of residence, adjustment of relevant policies, etc. Therefore, it is difficult to make an accurate projection, and all projected figures are subject to change. Against such backdrop, we provided earlier on the estimated number of overall demand of KG places for 2014/15 (i.e. about 168 000 as mentioned above) based on existing information. The estimation is derived with reference to the actual number of KG students in the 2012/13 school year, newly-arrived children from the mainland and cross-boundary students as well as estimation of the actual percentages of Type II babies (born to Mainland women in Hong Kong and whose fathers are non-permanent residents of Hong Kong) settling in Hong Kong. Later this year, we will get hold of the respective information for the 2013/14 school year. The information will help us make a more accurate estimation on the overall demand of KG places in the 2014/15 school year. On the issue of supply and demand of KG places, we have recently provided a reply to a question raised by the Legislative Council. The relevant document is at Appendix 1.

4. We will closely monitor the supply and demand of KG places in various districts. When needs for additional school places are identified, we will request KGs to optimize their campus capacities for providing more classrooms, encourage them to admit more students by making full use of their registered classrooms, such as re-commissioning vacant classrooms. We will also approach school sponsoring bodies and encourage them to expand or open KGs in districts with a high demand for school places.

### **KG Admission Arrangements**

5. KG education in Hong Kong has all along been provided by the private sector and is characterized by great flexibility, diversity, adaptability, vibrancy and responsiveness to parents' needs. Parents may choose a KG suitable for their children with regard to their needs, while admission is at the discretion of individual KGs.

6. KG students are of tender age. Long journeys to schools would have negative impact on their learning and growth. The EDB has all along been urging parents to choose for their children a KG in their neighborhood. As far as we know, the KG sector generally recognizes this viewpoint and will consider from the perspective of the interest of students and child care for student admission.

## Application Fees

7. Regarding Hon TIEN's concern over the alleged breach by some KGs of the Education Regulations in charging excessive application fees, according to Section 61(1) of the Education Regulations, KGs that wish to collect or revise the application fees should seek prior approval from the Permanent Secretary for Education in writing. The letter of approval shall be exhibited by the KGs at school notice boards or other public areas. At present, the approved KG application fee as stipulated by the EDB is capped at \$30. If KGs wish to collect an application fee which exceeds the approved ceiling, they should seek the prior approval of the EDB, which will evaluate the merits of the justifications before deciding whether to grant the approval. If KGs are found to have collected an application fee at an amount exceeding the approved ceiling without prior approval, we will follow up the cases, and request the KGs to rectify the irregularity and handle the matters according to established procedures.

## **Student Admission in Tai Po and North District**

8. According to our figures in hand, both Tai Po and the North District have sufficient KG places to cater for the demand of local and cross-boundary students, while the demand in the North District is relatively close to the supply. In view of the situation, we have met with representatives of the KG sector in Tai Po and the North District to gain an understanding of the recent situation whereby parents queued up for application forms at some KGs. Both the EDB and representatives of the sector have come to the view that the main causes of the situation are: limited application forms distributed by some KGs, parents' apprehension about possible keen competition for KG places, multiple applications by some parents and the involvement of intermediaries in queuing, etc.

9. We understand the pressure and concerns of parents in Tai Po and the North District. To address this matter on a special case basis, we have met representatives of the KG sector in the district to discuss contingency measures and consensus has been reached. We are going to implement six special temporary measures in Tai Po and the North District with a view to improving KG admission procedure and better utilizing the KG places within the district so as to dispel parents' doubts. These measures are:

### Online application forms

The EDB encourages KGs to provide online registration or allow parents to download application forms to save them the trouble of obtaining the forms in person.

### Unlimited supply of application forms

The EDB advises KGs against setting any quota for the number of application forms to be distributed. Online application forms aside, KGs should ensure adequate supply of printed application forms. The double-barreled approach will help ease the long queues for application forms and forestall the situation where parents may fail to obtain an application form despite queuing for an extended period of time.

### Principle of vicinity

For the benefit of child care and development as well as home-school cooperation, the EDB supports the principle of vicinity in admission of KG students. This will facilitate parents in securing a KG place for their children in their neighborhood.

### Additional places

The EDB has requested KGs to optimize their campus capacities for providing more classrooms, encouraged them to admit more students by making full use of their registered classrooms and re-commission vacant classrooms. We will also approach school sponsoring bodies and encourage them to expand or open KGs in districts with a high demand for school places. We have touched base with a number of KGs in the North District. To date, about five of them have already agreed during our brief meeting to consider converting existing rooms or space into classrooms. We will further discuss the feasibility of such arrangements with the KGs concerned and encourage more KGs to conduct room conversion if necessary and possible, to provide more places. It is noteworthy that the flexibility in the supply of KG places is higher than that in the secondary and primary school sector. As such, the preparation period for increasing the supply is comparatively shorter. EDB will closely monitor the situation and discuss with the KG sector on further increase of school places if necessary.

### One place per child

To prevent a child from holding a number of places at one time thereby causing parents of other children to worry about insufficient places for their children, KGs in Tai Po and North District have agreed on a centralized sign up date and a centralized registration date. After the sign up date, the KGs will submit all students'

particulars to the EDB for checking purposes. On confirming that parents have not enrolled in more than one KG, the EDB will issue a “Registration Letter” to each student whose parents are then required to submit the “Registration Letter” to the KG they have selected, and pay a registration fee<sup>1</sup> to complete the registration procedure. In case of transfer to another KG, the parents may withdraw the “Registration Letter” from the original KG and submit it to the KG they consider more suitable. Provisional administrative arrangements for the measure are set out at Appendix 2. The details are to subject to further discussion with the KG sector before confirmation.

### Support for parents

The EDB will enhance its enquiry and coordination services to provide information and assistance to parents whose children fail to secure a KG place. Where necessary, the EDB will consider setting up hotlines to provide parents with information on KG vacancies and help them apply for admission for their children.

10. Both the EDB and the sector consider that the above special measures will help to address the concerns of parents of KG students in Tai Po and North District. It is worth noting that with the implementation of the “zero delivery quota” from 2013 for Mainland expectant mothers whose husbands are not Hong Kong residents, the demand of KG places from locally-born children whose parents are not Hong Kong residents, including cross-boundary students, returning to Hong Kong for education is expected to drop from 2016 onwards. Hence, the keen competition for KG places in the above districts is transient and problems arising from intermediaries making profit out of parents’ concerns about insufficient KG places will be resolved in due course.

## **Way Forward**

11. Providing practicable 15-year free education and better quality KG education is one of the priorities of the current-term Government. The Committee on Free Kindergarten Education (the Committee), set up by the EDB on 8 April 2013, has started to examine the various issues relating to the

<sup>1</sup> The EDB has stipulated ceilings on registration fees chargeable by KGs. Currently, the ceilings for half-day and whole-day places are \$660 and \$1,150 respectively or half of the monthly tuition fee, whichever is the lower. To safeguard parents’ rights, the registration fee may be collected only when a place has been offered by the KG to a child, and the child must be credited with the amount of the registration fee in the first instalment of the tuition fee to be paid. Any child who has paid the registration fee when offered a school place but subsequently decides not to take the place may be considered as having forfeited the fee.

provision of free KG education in order to make practicable proposals on how to implement free KG education. Admission procedure is one of the issues to be reviewed.

12. In view of the intricacies of the issues involved, our estimation at this stage is that the Committee will take two years to complete its tasks. During this period, the Committee will maintain communication with the KG sector and proactively explore short- and medium-term measures which can help KGs meet their imminent challenges. The Government will actively consider providing support accordingly.

LEGCO QUESTION No. 4**(Oral Reply)**Asked by: Dr Hon LAM Tai-faiDate of Meeting: 23 October 2013Replied by: Secretary for Education**Question:**

It has been reported that, early this month, a large number of parents of cross-boundary students queued up overnight for admission application forms outside the kindergartens in districts such as the North District and Tuen Mun, etc. which gave rise to a phenomenon of intermediaries queuing on behalf of the parents. Some mainland parents criticized the kindergartens concerned for the improper arrangements, while local parents marched to protest about cross-boundary students affecting the opportunities of local children to study in kindergartens close to their homes. Moreover, owing to the “Year of the Dragon” effect, the number of children born in Hong Kong in 2012 is higher than those in other years. As such children will apply in the next year for kindergarten places in the year after next, some parents in Hong Kong are worried that the competition for kindergarten places next year will be even more intense than this year. In this connection, will the Government inform this Council:

- (a) of the respective numbers of local and international kindergartens in each of the past five years, broken down by District Council district, the respective numbers of places in Nursery, Lower and Upper classes provided by those kindergartens, as well as the respective numbers of cross-boundary students who applied for and were admitted to those kindergartens;
- (b) whether it has projected the demand for kindergarten places in Hong Kong in the coming five years and, among such places, the number of those which will be taken up by cross-boundary students; if it has, of the relevant figures and the details of the method adopted for the projection; if not, the reasons for that; and
- (c) given that the Secretary for Education said publicly on 7 October this year that kindergartens could use vacant classrooms to flexibly provide places for different classes, of the respective numbers, according to the Government’s estimation, of kindergartens in the North District, Tuen Mun, Yuen Long and Tai Po which can provide additional places through this method in the 2014-2015 school year, as well as the respective numbers of places to be flexibly provided in each of these districts through using vacant classrooms; the respective numbers of cross-boundary students which the authorities expect to be admitted by the kindergartens in these districts in the 2014-2015 school year ?

**Reply:**

President,

Our reply to the question raised by Hon LAM is as follows:

- (a) Distribution of local and non-local kindergarten (KG) by district, distribution of students and places in local and non-local KG by district and by class level, as well as distribution of cross-boundary KG students by district for the past five years, i.e. 2008/09 to 2012/13 school years, are set out at Annexes 1, 2 and 3 respectively.

KGs, including KG-cum-child care centres, in Hong Kong are all privately-run. It is up to the parents to choose whether to apply for one or more KGs suitable for their children with regard to their needs. As for student admission, it is at the discretion of individual KGs. Hence, the Education Bureau (EDB) does not have statistics on the number of KG applicants (including the number of cross-boundary applicants).

- (b) In projecting the overall demand of KG places in Hong Kong, we will take into account factors including:

- (1) the number of students (including cross-boundary students) already in KGs;
- (2) the projected school age population, which is compiled based on the population projections and the latest demographic changes (including the number of newly-arrived children from the Mainland) as updated by the Census and Statistics Department from time to time;
- (3) the KG attendance rates for children of different age groups and the latest trend; and
- (4) the estimated number of cross-boundary students.

Among the above factors, the population projections are based on a number of factors and assumptions. Of particular relevance is that related to babies born in Hong Kong to Mainland women. However, it is difficult to predict with accuracy the actual numbers of such babies who would settle in Hong Kong and if so, when. As for the number of cross-boundary students, it is subject to year-on-year changes depending on family factors, distribution of their places of residence, adjustment of relevant policies, etc. Therefore, it is difficult to make an accurate projection. For these reasons, we will only estimate the number of KG students for the coming year in the annual controlling officer's report. As for the long-term projection of the overall demand of KG places, we consider it only suitable for internal reference.



In view of the public concern about KG places recently, we have made an estimation regarding the overall demand of KG places for the 2014/15 school year (about 168 000) and the number of students aged three to five (including cross-boundary students) for the 2014/15 school year in the four districts close to the boundary control points earlier than usual (Annex 4). In estimating the demand, we have made reference to the actual number of KG students in the 2012/13 school year and taken into account the number of cross-boundary students already attending KGs in Hong Kong and the year-on-year progression of these students. Later this year, when we get hold of the actual number of KG students in the 2013/14 school year, we will be able to estimate more accurately the overall demand of KG places for 2014/15.

- (c) We will closely monitor the supply and demand of KG places in various districts. When needs for additional school places are identified, we will request KGs to optimize their campus capacities for providing more classrooms and encourage them to admit more students by making full use of their registered classrooms such as re-commissioning vacant classrooms. We will also approach school sponsoring bodies and encourage them to expand or open KGs in districts with a high demand for school places. Some school sponsoring bodies have responded positively to the EDB's appeal and already decided to open new KGs in the North District in the 2014/15 school year.

In the 2012/13 school year, there were about 5 200 school places available in vacant classrooms, involving about 60 KGs, in Tuen Mun, the North District, Tai Po and Yuen Long. Details are given in Annex 5. Later this year, when we get hold of the actual number of KG students and the number of school places for the 2013/14 school year, we will be in a better position to make a more accurate estimation on the number of vacant classrooms and school places available in the 2014/15 school year.

The estimated numbers of students aged three to five (including cross-boundary students) in the North District, Tuen Mun, Yuen Long and Tai Po for the 2014/15 school year are set out at Annex 4. With the announcement by the EDB of the six special measures relating to admission of KG students in Tai Po and North District for 2014/15, it is difficult for us to estimate at this stage the number of cross-boundary students to be admitted to KGs in Hong Kong.
